Senior Programmer Analyst

Position

Under the direction of the Programming Supervisor, the position's primary responsibility is application development for the Gaming Control Board's Technology division. This involves all aspects of development from business process analysis and requirements gathering to implementation including designing, developing, testing, debugging and supporting applications. The qualified individual will assist in developing application development strategies and perform related work as required.

Description

Designs, develops, tests, debugs, and documents software applications and systems that support the mission of all Board divisions. Applies knowledge of development techniques and technology to satisfy user requests or application development objectives. Leads efforts with business users and technical team to review current applications and procedures and develop business and technical requirements. Designs technical and business process flowcharts, data models and entity relationship diagrams based on business and technical requirements. Converts requirements into software applications and systems. Tests modules and applications prior to user testing. Creates system documentation of developed software modules and applications

Primary Requirements

Candidates must have 4+ years with application design and application development using Java, preferably within the My/SQL, Linux, Apache/Tomcat platform. 4+ years experience with JSP, html, JavaScript and shell scripting. Knowledge of the Java Server Faces framework and AJAX is a definite plus. The ideal candidate will have experience with development tools such as Toad, Netbeans, Eclipse or similar tools. They will also have a deep understanding of Linux and its related tools and applications.

Ideal candidates will have experience with PHP, Oracle, PL/SQL, Code management systems and XML. Candidates must have excellent oral and written communication as well as experience with formal QA processes and coding standards.

Other Requirements

- Advise Information Technology Management on policy decisions affecting the delivery of business information systems to the Gaming Control Board.
- Help identify and implement best practices as they relate to application development in existing and future Board development projects.
- Ability to lead application development projects through to completion.
- Work with internal and external customers in defining business needs and identifying cooperative relationships to improve business processes.
- Help establish security policies and procedures for applications.
- Meet on a regular and timely basis with IT management, project managers, and staff as needed to ensure proper communication flow, project status, and implementation schedules.
- Ability to interface with a wide variety of users to determine business requirements. Ability to translate business requirements to efficient, useful applications.
- Resolve issues presented by management, staff, and business users regarding work processes, policies, procedures, and methods.
- Strong interpersonal, communication, and project management skills are critical to the job

Knowledge of: Principles, organization, planning, project management, and current computer industry technology and practices; principles of information systems design, application development, operations, and controls

Top 5 required technical skills:

1. Java development
2. AJAX application development
3. Apache/Tomcat configuration and management
4. LINUX experience
5. Database design and development

Graduation from an accredited college or university with a bachelor's degree in computer science, information systems, systems analysis, or development and maintenance of database software applications in a business setting; or an equivalent combination of education and experience
