## Win Revenue Summary – April 2023

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,159,751,632 for the month of April 2023. This amounts to a 2.77% <u>increase</u> compared to April 2022, when licensees reported a gaming win of \$1,128,502,208. For the fiscal year (July 1, 2022 through April 30, 2023), gaming win has increased 4.30%.

## Percentage Fee Collections for the Month of May 2023

The State collected \$67,455,873 in percentage fees during the month of May 2023\*, based upon the taxable revenues generated in April 2023. This represents a 3.44% (or \$2,403,521) decrease compared to the prior year's May, when percentage fee collections were \$69,859,394.
