Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2023

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,270,598,215 for the month of September 2023. This amounts to a 1.69% <u>increase</u> compared to September 2022, when licensees reported a gaming win of \$1,249,470,541. For the fiscal year (July 1, 2023 through September 30, 2023), gaming win has increased 2.91%.

Percentage Fee Collections for the Month of October 2023

The State collected \$77,616,809 in percentage fees during the month of October 2023*, based upon the taxable revenues generated in September 2023. This represents a 3.59% (or \$2,889,724) <u>decrease</u> compared to the prior year's October, when percentage fee collections were \$80,506,533.
