Nevada Gaming Revenues and Collections

Win Revenue Summary – January 2024

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,279,418,577 for the month of January 2024. This amounts to a 0.51% <u>increase</u> compared to January 2023, when licensees reported a gaming win of \$1,272,953,912. For the fiscal year (July 1, 2023 through January 31, 2024), gaming win has increased 4.77%.

Percentage Fee Collections for the Month of February 2024

The State collected \$99,713,357 in percentage fees during the month of February 2024*, based upon the taxable revenues generated in January 2024. This represents a 3.74% (or \$3,597,051) <u>increase</u> compared to the prior year's February, when percentage fee collections were \$96,116,306.
