Good morning and happy New Year to you all. My name is Diamante Asberry, and I'm here on behalf of the Culinary Union.

Culinary Union members just won a record breaking contract. The Culinary Union's new contract at 23+ properties on the Strip guarantees \$9.21 in an economic package increase over five years.

Every worker will be getting a 10% wage increase in the first year retroactive to June 2023 and a total of 32% in raises over the life of the new contract.

Culinary Union members on the Strip have once again fought and won a first-class standard for themselves and their families.

Meanwhile, Station Casinos workers are still being treated like second-class workers.

Station Casinos does not provide benefits equally to all workers—providing some employees benefits about life, death, and money while denying the same benefits to other employees. Station Casinos could have stopped its discrimination against workers any day in 2023, but they refused. Over the course of workers unionizing and fighting discrimination, Station Casinos has implemented enhanced benefits because workers have stood up, organized, and demanded better.

Station Casinos management created MUD lists, tracking which workers were promanagement, pro-union, or "don't know." Station Casinos property directors used these MUD lists to decide which workers to rehire during the pandemic. These MUD Lists caused damage to Stations workers and their families.

Workers at Station Casinos properties voted for the union and won elections by large margins despite the company fighting their organizing efforts. These workers are *still* fighting for the company to respect their voices and bargain a fair collective bargaining agreement with the Culinary Union.

Station Casinos workers deserve first-class standards like other hospitality workers throughout the city. They deserve dignity and respect.

Mi nombre es María Espinoza. He trabajado para Palace Station en el departamento sanitario durante 20 años.

Soy miembro del comité sindical. Hago saber que esta empresa no respeta mis derechos como empleada. Voy a trabajar incluso cuando no me siento bien. Tengo miedo de perder mi trabajo. Yo quiero un contrato para asegurar mi trabajo.

Muchos de mis compañeros de trabajo en Palace Station han renunciado o han sido despedidos por la compañía. Y parece que mis compañeros que siguen aquí están estresados y se enferman más frecuente.

Despidieron trabajadores durante la pandemia, y ahora nos han vuelto a contratar a algunos de nosotros como nuevos empleados. Creo que algunos de los recontratados tienen un salario más bajo y no tienen su antigüedad.

Cerraron 3 propiedades y sacaron a esos trabajadores de sus trabajos. Y en mi trabajo, parece que los aumentos no se dan por igual. Parece que la gerencia divide a los trabajadores.

Queremos que nos ayude. Hemos trabajado duro y queremos algo mejor de la compañía. Queremos un contrato. Queremos seguridad laboral. Queremos respeto.

My name is Maria Espinoza. I have worked for Palace Station in the sanitation department for 20 years.

I am a committee member for the Culinary Union. I am making it known that this company does not respect my rights as a worker. I go to work even when I am not feeling well. I am afraid I may lose my job. I want a contract to secure my job.

A lot of my coworkers at Palace Station have quit or been fired by the company. And it seems like my coworkers who are still here are stressed and they get sick more often.

They terminated workers during the pandemic, and now they have re-hired some of us as new employees. I believe some of those re-hires are a lower salary and don't have their seniority.

They closed 3 properties and put those workers out of their jobs. And in my job, it feels like raises are not given equally. It feels like management divides the workers.

We want you to help us. We have worked hard, and we want better from the company. We want a contract. We want job security. We want respect.
