SUBJECT: NOTICE OF WORKSHOP REGARDING THE POSSIBLE ADOPTION, AMENDMENT, OR REPEAL OF REGULATIONS PERTAINING TO CHAPTER 368A OF THE NEVADA ADMINISTRATIVE CODE

NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATION AMENDMENTS

The State Gaming Control Board is seeking input from interested persons regarding the possible adoption, amendment, or repeal of regulations pertaining to Chapter 368A of the Nevada Administrative Code (Live Entertainment Tax) as it applies to licensed gaming establishments. A workshop has been set to take place immediately following the regularly scheduled State Gaming Control Board Meeting, but no earlier than 1:00 p.m., on Wednesday, May 7, 2014, at the State Gaming Control Board offices, 555 East Washington Avenue, Las Vegas, Nevada 89101, in Hearing Room 2450, with video-conferencing to the State Gaming Control Board Offices, 1919 College Parkway, Carson City, Nevada 89702. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed amendments to the regulations:

- Whether to amend the definition of "patron" in NAC 368A.370, to define the term "immediate area" as used in NRS 368A.090(2)(b)(4), to define the term "occasional activity" as used in NRS 368A.090(2)(b)(8) and to define the term "service charge" as used in NRS 368A.200(2)(b);
- 2. Whether to adopt regulations providing for the disposition of an over-collection of live entertainment tax;
- 3. Whether to adopt regulations establishing a procedure whereby a taxpayer that is a licensed gaming establishment may request an exemption from the tax pursuant to NRS 368A.200(5)(q);

- 4. Whether to amend provisions related to the time periods in which live entertainment status is in effect;
- 5. To receive input concerning any other amendments to Chapter 368A of the Nevada Administrative Code that may be necessary; and
- 6. Other housekeeping matters as may be necessary.
