REGULATIONS

4. <u>CONSIDERATION OF</u>: Proposed amendment to <u>NGC REGULATION 3.015</u>, "<u>APPLICATIONS FOR</u> <u>RESTRICTED LICENSES</u>." to establish that it will be an unsuitable method of operation to materially change the nature and quality of the primary business conducted at an establishment after the restricted gaming license has been granted by the Commission without the prior administrative approval of the Gaming Control Board Chairman or his designee; to establish that a material change in the nature and quality of the primary business is presumed to occur if a zoning change is required, or a new business license, special use permit, or any other license, permit or approval must be obtained from the applicable city, county, or township licensing, zoning or approval authority, in order to change or operate the primary business in a manner that is different from what was being conducted at the time the gaming license was granted; to take such additional action as may be necessary and proper to effectuate these stated purposes.

DISCUSSION HELD, GCB TO HOLD WORKSHOPS.

5. <u>CONSIDERATION OF:</u> Proposed amendments to <u>NGC REGULATION 8.060, "PARTICIPATION IN</u> <u>OPERATIONS.</u>" To establish that no person who proposes to acquire an interest in any licensed gaming operation, in a licensee, or in a holding company shall take any part whatsoever, as an employee or otherwise, in the conduct of such gaming operations or in the operation of the establishment at which such gaming operations are conducted while his application for a license or for approval to acquire such interest is pending without the prior administrative approval of the board chairman; to establish that the board chairman may grant, deny, limit, restrict or condition a request made pursuant to this section for any cause he deems reasonable or refer the request for approval to the full board and commission for consideration; to establish that if the board chairman, acting in his sole and absolute discretion, does not within 30 days deny the request to continue employment, or provide written notification to the employee that the application is being referred to the full board and commission for consideration to participate shall be deemed approved; to take such additional action as may be necessary and proper to effectuate these stated purposes.

DISCUSSION HELD, GCB TO HOLD WORKSHOPS.

6. <u>CONSIDERATION OF</u>: Proposed amendment to <u>NGC REGULATION 22.135, "USE OF</u> <u>COMMUNICATION DEVICES PROHIBITED.</u>" To review the propriety of the use of communication devices such as cellular telephones, paging devices, radios and computers within race and sports books; to take such additional action as may be necessary and proper to effectuate these stated purposes.

DISCUSSION HELD, GCB TO HOLD WORKSHOPS.

7. <u>CONSIDERATION OF</u>: Proposed amendments to <u>NGC REGULATION 30, "HORSE RACING</u>." To clarify the definition of "association," "chairman," "licensee," "pari-mutuel wagering," and "place;" to clarify who must be licensed to conduct racing; to clarify who must file a bond with the board; to include an additional ground for refusal, denial, suspension, revocation, or conditioning of license; to prohibit certain individuals from the consumption of intoxicating liquor under specified circumstances; to provide additional licensing requirements for trainers, jockeys, horseshoers and veterinarians; to clarify coupled entries; to incorporate by reference certain provisions of the Association of Racing Commissioners Model rules regarding the calculation of payouts and distribution of pools; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
