THE CPA SHALL ALSO REVIEW, ON AN ANNUAL BASIS, ANY LOANS TO MEMBERS OR MANAGERS OF KARMA GAMING, LLC, TO ENSURE THEY HAVE BEEN PROPERLY EXECUTED AND ACCOUNTED FOR.
