The Nevada Gaming Commission (NGC) will hold a public hearing for the purpose of considering adoption, amendment or repeal of the regulation(s) stated below.

IN COMPLIANCE WITH THE GOVERNOR'S EMERGENCY DIRECTIVE #006, DATED MARCH 22, 2020, THE CONSIDERATION OF THE ADOPTION, AMENDMENT, OR REPEAL OF THE REGULATIONS STATED BELOW DURING THE MEETING OF THE NEVADA GAMING COMMISSION COULD BE CONDUCTED BY MEANS OF ELECTRONIC COMMUNICATION. ## **For Possible Action**

### **2020-05R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 9 REGARDING, WITHOUT LIMITATION, TEMPORARY CLOSURES.**

**PURPOSE:** In accordance with NRS 463.150, to clarify the period of time a licensee may close all of his or her licensed games after which time the license must be surrendered to the Board; to clarify that the Board Chair or the Chair's designee is delegated certain specified authority; to create a process to allow licensed gaming establishments to temporarily close in the event of an emergency declaration requiring the closure of a licensed gaming establishment; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. IF THE AUGUST NGC MEETING IS HELD BY MEANS OF ELECTRONIC COMMUNICATION, ANY PERSON DESIRING TO PRESENT STATEMENTS, ARGUMENTS OR CONTENTIONS CONCERNING THE PROPOSED REGULATION CHANGES MUST PROVIDE SUCH IN WRITING TO THE EXECUTIVE SECRETARY AT [regcomments@gcb.nv.gov](mailto:regcomments@gcb.nv.gov).

These items will be heard by the NGC at the August 27, 2020 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
