- (3) PRIOR TO THE ISSUANCE OF THE STATE GAMING LICENSE, THE LOCATION'S SLOT MACHINES MUST BE APPROVED BY THE NGCB'S ENFORCEMENT DIVISION. THIS CONDITION MAY BE ADMINISTRATIVELY REMOVED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE.
- (4) THIS PROVISIONAL LICENSE IS FOR THE OPERATION OF GAMING AT THE LICENSEE'S ESTABLISHMENT DURING ALL CALENDAR QUARTERS OF EACH YEAR. GAMING OPERATIONS MAY BE PERMITTED IN ALL CALENDAR QUARTERS OF EACH YEAR IF ADMINISTRATIVELY APPROVED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE IN ADVANCE OF THE COMMENCEMENT OF SUCH OPERATIONS. LICENSEE MUST PAY ALL APPLICABLE FEES AND TAXES FOR EACH QUARTER AND YEAR IN WHICH IT CONDUCTS GAMING AT ITS ESTABLISHMENT PURSUANT TO THE GAMING CONTROL ACT. THIS CONDITION MAY BE ADMINISTRATIVELY REMOVED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE.
- (5) WITHIN FIVE DAYS OF TEMPORARILY CEASING ITS GAMING OPERATION PURSUANT TO THIS PROVISIONAL LICENSE, THE LICENSEE SHALL PROVIDE THE NGCB CHAIR OR THE CHAIR'S DESIGNEE WITH WRITTEN NOTICE OF SUCH CESSATION. ALONG WITH SAID NOTICE, THE LICENSEE SHALL REMIT TO THE BOARD A SUM OF MONEY EQUAL TO THE QUARTERLY FEES FOR ONE CALENDAR QUARTER. SAID PAYMENT WILL SERVE AS A PREPAYMENT OF QUARTERLY FEES COVERING THE QUARTER IN WHICH THE LICENSEE RESUMES ITS GAMING OPERATION.
