**PURPOSE**: To delete the definition of "secondary representative" as unnecessary; to clarify which independent agents are subject to registration with the Board; to modify reporting requirements; to require registration renewals be submitted at least 30 days prior to the expiration of the registration; to clarify that registrations expire every five years; to make the period in which the Chair may object to a registration explicit; to update the mandatory requirements for independent agent agreements; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
