On behalf of our members, I write today in support of the 2020-05R, the proposed amendments to Regulation 9 regarding temporary closures and respectfully ask that the amendments be approved.

As the Gaming Control Board is keenly aware, Nevada's gaming industry is doing everything it can to safely resume or expand operations and bring employees back to work to help expedite the revival of our state's economy and generate much needed tax revenue. Given the unpredictable nature of this public health emergency, flexibility is critical as licensees evaluate how to resume operations in an uncertain environment.

The proposed amendments to Regulation 9 provide the industry with necessary flexibility and relief during an emergency declaration for the overall health of Nevada's largest industry. No licensee should be in jeopardy of losing their licenses as a result of communitywide circumstances beyond their control.
