**2020-04R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 26C REGARDING, WITHOUT LIMITATION, PARI-MUTUEL HORSE WAGERING ACCOUNTS.**

**PURPOSE:** To update account wagering system requirements so they are in-line with the account wagering requirements found in Regulation 22.145, including removing the requirement of separate wagering accounts for pari-mutuel horse race wagering, acceptance of out-of-state nonpari-mutuel wagers if they become legal, and references to other events; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

- (1) 3 CORNERS LLC SHALL, WITHIN 90 DAYS FOLLOWING THE DATE OF THE SEPTEMBER 2020 COMMISSION MEETING, ESTABLISH AND MAINTAIN A GAMING COMPLIANCE PROGRAM FOR THE PURPOSE OF, AT A MINIMUM, PERFORMING DUE DILIGENCE, DETERMINING THE SUITABILITY OF RELATIONSHIPS WITH OTHER ENTITIES AND INDIVIDUALS, AND TO REVIEW AND ENSURE COMPLIANCE BY 3 CORNERS LLC, AND ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES, WITH THE NEVADA GAMING CONTROL ACT ("THE ACT"), AS AMENDED, THE COMMISSION'S REGULATIONS ("THE REGULATIONS"), AS AMENDED, AND THE LAWS AND REGULATIONS OF ANY OTHER JURISDICTION IN WHICH 3 CORNERS LLC, ITS SUBSIDIARIES AND ANY AFFILIATED ENTITIES OPERATE. THE GAMING COMPLIANCE PROGRAM, AND ANY AMENDMENTS THERETO, SHALL BE ADMINISTRATIVELY REVIEWED AND APPROVED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE, AND THE MEMBERS OF THE COMPLIANCE COMMITTEE, ONE SUCH MEMBER WHO SHALL BE INDEPENDENT AND KNOWLEDGEABLE OF THE ACT AND THE REGULATIONS, SHALL BE ADMINISTRATIVELY ACKNOWLEDGED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE. 3 CORNERS LLC SHALL AMEND THE GAMING COMPLIANCE PROGRAM, OR ANY ELEMENT THEREOF, AND PERFORM SUCH DUTIES AS MAY BE ASSIGNED BY THE NGCB CHAIR OR THE CHAIR'S DESIGNEE, RELATING TO A REVIEW OF ACTIVITIES RELEVANT TO THE CONTINUING QUALIFICATION OF 3 CORNERS LLC, UNDER THE PROVISIONS OF THE ACT AND THE REGULATIONS.**
- (2) 3 CORNERS, LLC SHALL FUND AND MAINTAIN WITH THE BOARD A REVOLVING FUND IN THE TOTAL AMOUNT OF \$25,000 FOR THE PURPOSE OF FUNDING INVESTIGATIVE REVIEWS BY THE BOARD. WITHOUT LIMITING THE FOREGOING, THE BOARD SHALL HAVE THE RIGHT, WITHOUT NOTICE, TO DRAW UPON THESE FUNDS TO PAY THE COSTS AND EXPENSES INCURRED BY THE BOARD AND ITS STAFF IN THE SURVEILLANCE, MONITORING, AND INVESTIGATION OF ALL ACTIVITIES OF 3 CORNERS, LLC, AND IT'S SUBSIDIARIES, AND AFFILIATED COMPANIES.**

- (4) THE MANUFACTURER'S LICENSE IS LIMITED TO THE MODIFICATION OF MACHINES THAT ARE, OR HAVE BEEN, UTILIZED IN THE OPERATIONS OF THE LICENSED LOCATION OR ITS AFFILIATED COMPANIES AND THAT ANY SUCH MODIFICATIONS SHALL BE LIMITED TO OPERATIONAL CONFIGURATION CHANGES SUCH AS REPLACEMENT OF ONE PRE-APPROVED COMPONENT WITH ANOTHER PRE-APPROVED COMPONENT OR MODIFICATIONS THAT WILL NOT AFFECT THE MANNER OR MODE OF PLAY OF THE DEVICE.**
- (5) THE DISTRIBUTOR'S LICENSE IS LIMITED TO THE ACQUISITION OF MACHINES TO BE UTILIZED IN, OR THE DISTRIBUTION OF MACHINES WHICH HAVE BEEN UTILIZED IN, THE OPERATIONS OF THE LICENSED LOCATION OR ITS AFFILIATED COMPANIES.**
