The fact that I provided solidified proof to the Nevada gaming commission (via screenshots & video) that WillHill accepted a pregame wager after a game had already started, but my Father is required to expose himself to the possibility of WillHill deactivating his account to come to a resolution is asinine.

The gaming commission should be willing to act on a bettor's behalf.

The lab stated they found no issues with the app and they got it wrong as my evidence clearly indicates.

A video is attached that I took showing the same problem occurring on the WillHill app, but at a later date.

I submitted a complaint on behalf of my Father regarding the WillHill app to Derrick Agnew & Dillon Meeks and frankly, I don't feel it was handled properly.

I was informed that if I submitted a report that there was a chance that my Father's account could be disabled at WillHill so we elected to submit an anonymous report for a Regulation 14 investigation and this was the response "The report that I received from the lab is stating the app is functioning properly. As I told you on the phone since the wager is placed before the game starts it is deemed ok. The lab deemed the app as operating within the guidelines they have been given."

I was under the assumption the gaming commission was created to protect both the customer & the operator and it seems that issues like this put the customer in a precarious situation having to decide whether it's worth it to report an issue that may result in a deactivated account.

My father Larry Miller attempted to make a wager on the WilliamHill app and it would not locate so he took his action elsewhere. Later, when he checked his account he realized the bet had been processed after the game had started, and effectively he suffered double the losses due to the application error. Please see the screenshots attached for proof.

He attempted to tap "clear wagers" at the top left while it was processing and then even went as far as doing a hard reset on his phone to ensure it didn't process. There's no reason a bet should take 3 minutes to process. And not only that, but the game should have been off the board when the bet was processed at 5:23:22 pm.

I was left a voicemail by agent Agnew stating "Your Father did make the wager, he did intend to make the wager and even tho it wasn't accepted for a couple of minutes after the game had started there still was a wager."

Under Nevada Gaming Law, is a Nevada sportsbook operator allowed to accept a pregame wager after a game has already started?

Agent Agnew stated in part that my Father's wager was considered a valid wager based on intent. Does that also mean if a customer attempts to make a wager and it doesn't get confirmed they can keep a screenshot of their intended wager to submit to gaming to show the intent to make the wager and it would then be considered valid?

Here is the timeline my Father put together to show his experience attempting to use the app: 5:18pm - Submitted Wager 5:19pm - Processing - Took Screenshot 5:20pm - Processing - GAME KICKED OFF 5:21pm - Processing - Took Screenshot 5:23pm - Hard Reset his Phone 5:23:22pm - Wager Processed 3 minutes and 22 seconds AFTER game had started

A sportsbook operator should not be allowed to accept a pregame wager after a game has already started. It is a clear unfair advantage for the operator to view over 3 minutes of gameplay before accepting a wager. What if a team ran the kickoff back? Would it be fair for the operator to have the option to accept/reject a pregame wager after that event occurred? Conversely, would it be fair for a customer to have the ability to submit a pregame wager after a team scored? If the gaming commission chooses to overlook this, it is a blatant disregard to the customer and a clear bias/advantage to the sportsbook operator. And even if it is software accepting a wager there is no reason any software program should be able to confirm a pregame wager after it has gone off the board. That's like allowing someone to bet on a horse race after they leave the gate. It just shouldn't happen. Why can't a ticket writer at a sportsbook confirm a wager 3 minutes after a game has gone off the board, but WillHill app can?

It is our hope that we can come to a fair resolution and that our experience will incite change in the future.

GameCo Public Comment Statement Justin Yamek

Hello, my name is Justin Yamek and I represent Beyond Gaming. From as early as I can remember I was helping my uncle refurbish mechanical slot machines. He sold them then and still does today. His wife, my Aunt, owned an arcade I spent a lot of time at. My interest in video games and gambling started at a young age. My love for the sounds, sights and the machines themselves was undeniable.

In 2008 I was going to compete in a video game tournament in Las Vegas for a large cash prize. My team couldn't afford the trip and my daughter was born that same weekend. Since we couldn't make it to Las Vegas I wanted to come up with a way for people to play video games and win money more easily. In 2009 my friend Dan, my brother in law Tony and I formed Beyond Gaming. We built a website that allowed gamers to wager money on video games and play in tournaments for cash and prizes. We made money by taking a rake. One thing that made us stand out from our only other competitor was that we automatically verified the results of the match. It was successful from the start. Our slogan was "Play For \$omething".

We spent the next 5 years building the company and our software. Our team of around 10 lived and breathed Beyond Gaming. At times we worked for multiple days and nights non-stop to hit our deadlines. Our motto was "Teamwork makes the dream work". Everything was going very well. We had partnered with some of the largest video game companies in the world and we had over 200,000 users.

We had always talked about having ways for people to bet on video games in person. We started talking with a casino company, Rock Gaming, about bringing video games to casino floors. In 2012 Tony stepped down as CEO and Blaine Graboyes took over. In 2013 we decided to host a Video Game Casino Night with Rock Gaming. Our team stepped up and developed 4 different gaming prototypes in development where players could bet on video games. One of the gaming prototypes was a racing game where a player would bet on whether they would complete a race track in a certain amount of time. The Casino Night was a huge success.

We already allowed players to wager on the racing game on our website but in early 2014 we decided to automate the racing game prototype from the Casino Night and build a prototype that worked similar to a traditional slot machine. I helped build the cabinet and the race tracks. Dan and the rest of the team built the software and prepared the hardware. We ended up calling it the Video Game Gambling Machine, or VGM. This too was a hit. We started talking with another large casino company, Caesars, and they wanted to fast track it and get our VGMs on their casino floors as soon as possible. We were all extremely excited and felt that all the hard work we had put into Beyond Gaming was going to pay off.

Blaine was a good CEO at first but something changed. He offered to buy our prototypes and the intellectual property we developed as a team to start a new company called GameCo that would build the VGMs. The offer was very bad for us. He cut everyone out of the team except for Dan. The rest of the team would be left behind with very small ownership of GameCo. We could not accept it, neither could Dan. Blaine then filed for bankruptcy for Beyond Gaming and took our prototypes and intellectual property. The bankruptcy paperwork was signed off by our board member Robert Montgomery, a cofounder of GameCo. They left the prototypes and intellectual property off the bankruptcy. GameCo now has VGMs on casino floors that are similar or nearly

exactly the same as the concepts we developed at Beyond Gaming. Blaine used Beyond Gaming's whitepaper that explains the VGM to get 2 patents.

It was devastating to say the least. We trusted Blaine and he crushed our dreams. A close-knit team of approximately 10 Beyond Gaming employees, from founders to interns, had to part ways after so much excitement. It was very hard on everyone. He was a mentor and father figure to many of us. Not only did it hurt our company, it hurt us personally. One team member spent months in the hospital due to what they did. We will never forget what Blaine and Robert did to us. They left deep scars that have yet to fully heal.

We are good and reasonable people. If they handled the situation better we would all still be in business together. They chose to be greedy though and we hope they don't do the same to other good people. That is why we are here today. Hopefully this is the beginning of the end of our pain and they don't treat others the way they treated us.

Thank you for taking us seriously Nevada.
