My name is Michael Furman. I moved to Nevada 30 years ago from New York because at that time Nevada seemed to have more liberties than New York. Over the years as more and more people moved to Nevada, Las Vegas in particular (700k to 2.1M now), it appears we're not as free to choose anymore. Our state was locked down while many were open, some wide open. As a horse player I wanted to play horses but couldn't because the casinos were closed and their app to play horses was too. When we were finally able to play horses on the app there was a dispute between the Pari-Mutuel Association and one major group, Churchill Downs Inc. As a result there was a limited betting menu for the Kentucky Derby, no wagering at all on any other races that day and no betting on any races from Churchill Downs, Fair Grounds, Presque Isle, Turfway Park, and Arlington Park to this day.

The Pari-Mutuel laws were written about 30 years ago, well before the internet became ubiquitous.

A change is needed. I shouldn't have to drive four hours to California to bet the Kentucky Derby race card this year if that will even be possible. An easy fix would be to allow horse players to open a TVG horse racing account for betting on any racetrack not on the betting menu in Nevada. That should be able to be negotiated. If TVG doesn't want to perhaps there is a company that would.

The bottom line is I could live one state over in California and bet any track I want to including overseas tracks but in Nevada I can only bet on tracks the Pari-Mutuel Association wants me to. Isn't it ironic that I could have more betting options in New York, the state I left, than here? This seems wrong in today's digital world.

The Casino's make it impossible for Nevadans to open TVG accounts, play the lottery and bet the tracks holding many prep races. These actions also won't draw crowds to visit Las Vegas for the Triple Crown Series as they are unable to bet the entire card.

The fact that I either have to travel to other states to enjoy these races in ridiculous with all the pari mutual off track betting going on around the country. Maybe it's time for Nevada to have off track betting locations outside of the Casino's? This would generate revenue for the state, create jobs and please the players! Being forced to open an account outside of the state is becoming a necessity for the real horse player. This is no different than not being able to bet the lottery as well. Yet another ridiculous move by our state that could create jobs, revenue for the state which could help offset our Medicaid Liability. How is it possible that we want locals to travel outside of the state and wager when they should be able to within our own state.

If I decide to run for office I promise these will be issues that I will address or I will be sure to lobby our elected to consider changing our laws. We are allowing other states to really cut into our bottom lines! New Jersey is now the Sports Betting Capital of the World and also books every major racetrack. How is that possible?
