PURPOSE: To amend the Nevada Gaming Commission ("NGC" or "Commission") Regulation 8.130 to adjust the thresholds for reporting certain transactions to the Nevada Gaming Control Board ("Board"); To remove the requirement that the described financing agreement be submitted to the Board; To add provision to require that documents supporting the reported transactions be maintained by the licensee for a certain period of time and that such documents be provided to the Board upon request; To require a licensee to perform due diligence prior to engaging in a contractual agreement with a party that triggers the supplemental filing requirement described in subsection 8 of this section; To make non-substantive changes to the language of this section to conform with current drafting standards; To update references to other sections of the regulations; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.
