PUBLIC COMMENTS AND DISCUSSION: No comments.

Good morning to the board. My name is Diamante Asberry, and I'm here today representing the Culinary Union.

Two weeks ago the Secretary-Treasurer of the Culinary Union, Ted Pappageorge, delivered a public comment to the Gaming Commission. I want to relay those comments to you today:

Five months ago the Culinary Union submitted a letter to Nevada gaming regulators about Station Casinos that made our position very clear. We believe regulators should regulate, and that means investigating Station Casinos and taking disciplinary action.

Since that letter was submitted Station Casinos workers have come to every Nevada Gaming Control and Gaming Commission meeting to tell you why you need to act. They have not missed a meeting and they've told you how bad Station Casinos treats the workers that run the industry you regulate.

So I'm here today with Station Casinos workers to get some answers. Frankly, Station Casinos workers and all gaming industry workers in Nevada have a right to know whether our state regulators have the power to discipline bad actors. If you can't act here, if you are powerless, we want you to tell us.

And by all means, if you are powerless here, tell us what we can do to give you the powers to hold bad actors like Station Casinos accountable.

Station Casinos has a huge footprint in this valley and their actions have a wide reach in our community. So we all suffer when they are not held accountable.

We owe Station Casinos workers so much because they've dug in and they've stood up to this company time and time again. Workers are holding Stations accountable, and frankly you need to do the same.

If you're not able to hold Stations accountable, just say so. If license holders can do what Stations did during the pandemic and is doing now and you're not sure what you can do, tell that to the workers.

We think working people are owed some answers. Thanks.

My name is Maria Espinoza. I have worked for Palace Station in the sanitation department for 18 years.

I am a committee member for the Culinary Union. I am making it known that this company does not respect my rights as a worker. I go to work even when I am not feeling well. I am afraid I may lose my job.

They terminated workers during the pandemic, and now they have re-hired some of us as new employees. I believe some of those re-hires are a lower salary and don't have their seniority.

They closed 3 properties and put those workers out of their jobs. And in my job, it feels like raises are not given equally.

We want you to help us. We have worked hard, and we want better from the company.

Thank you.

Soy miembro del comité sindical. Hago saber que esta empresa no respeta mis derechos como empleada. Voy a trabajar incluso cuando no me siento bien. Tengo miedo de perder mi trabajo.

Despidieron trabajadores durante la pandemia, y ahora nos han vuelto a contratar a algunos de nosotros como nuevos empleados. Creo que algunos de los recontratados tienen un salario más bajo y no tienen su antigüedad.

Cerraron 3 propiedades y sacaron a esos trabajadores de sus trabajos. Y en mi trabajo, parece que los aumentos no se dan por igual.

Queremos que nos ayude. Hemos trabajado duro y queremos algo mejor de la compañía.
