

# Nevada Gaming Commission, 3/17/2022

Good morning, my name is Robert Franz. I am here today to tell you about my experience working at Red Rock Casino and why I believe we need to have a union and a union contract there.

I started working at Red Rock as a banquet server back in November, 2006. I worked there for 14 years, got great annual reviews and had a terrific attendance record, and I made my way up from oncall to full-time. Full-time meant that I was scheduled first when events were booked. I was loyal to the company and passed on opportunities to go work at new properties such as Resorts World and Caesars Forum. I even bought a house near Red Rock. In 2020, everything changed. When Red Rock re-opened after the shutdown, I was not brought back to work in spite of my years of service and excellent performance over the years. Instead of



back, they hired new people in the banque department, people who had no experience with the company. I was told to interview for my old job, and I was not offered the job.I was eventually rehired in the summer of 2021, but I lost all my seniority, and I would only be working on-call. Now I have to compete with other banquet workers for work in spite of my 14 years with the company before 2020.I have represented my co-workers as a union committee person since late 2018. I knew back then that we need to have a union and a union contract to protect our jobs. What happened to me these last years has unfortunately proven me right. That's why I am still fighting to win a union contract at Red Rock. It is not fair what this company did to me and other workers who never got their jobs back. Please help us.

Station Casinos is a company with a long history of undermining election results. Station workers have time and time again won the vote to unionize only to see their employer try to deny the power of that vote.

Last month, *Time Magazine* published an article about how some companies will do just about anything to stop workers from unionizing and the article talked about Station Casinos and what companies do to undermine union elections.

An example from the article in *Time* is a so-called Station Casinos MUD list of its own workers. Station Casino executives allegedly ordered supervisors to prepare a "MUD list" to indicate which employees were pro-management, pro-union or don't know. So MUD is acronym where M meant "management," U meant "union" and D meant "don't know."

How would it make you feel if your boss put you on a MUD list? Workers at Station Casino voted for the union and won elections. They won the vote by large margins at Station Casinos properties and won the vote despite Station Casinos fighting their organizing efforts. 67% voted Yes for the union at Boulder Station, 78% at Green Valley Ranch, 82% at Sunset, and 85% at Fiesta Rancho in June 2019. After a lengthy hearing about an election at Red Rock, an NLRB Administrative Law Judge recommended that the NLRB find Red Rock guilty of widespread labor law violations, and a federal judge in Nevada found the evidence so convincing that she issued a rare injunction and interim bargaining order. Maybe it's no surprise that it was about the time of the Red Rock election that Station Casinos started using MUD lists. The MUD list started in September 2019. Station Casinos executives ordered supervisors to take the time to create an itemized list of who is with us and who is against us. Station used these MUD lists in its efforts to bust the union.

We have to pick a side. The side of Station Casinos MUD lists, election interference, and election undermining. Or the side that respects the vote and respects democracy. Which side are you on? Thank you.
