- (1) BETFRED GROUP LIMITED SHALL ESTABLISH AND MAINTAIN A GAMING COMPLIANCE PLAN FOR THE PURPOSE OF, AT A MINIMUM, PERFORMING DUE DILIGENCE, DETERMINING THE SUITABILITY OF RELATIONSHIPS WITH OTHER ENTITIES AND INDIVIDUALS, AND TO REVIEW AND ENSURE COMPLIANCE BY BETFRED GROUP LIMITED AND ANY AFFILIATED ENTITIES, WITH THE NEVADA GAMING CONTROL ACT, THE COMMISSION'S REGULATIONS AND THE LAWS AND REGULATIONS OF ANY OTHER JURISDICTION IN WHICH BETFRED GROUP LIMITED, AND ANY AFFILIATED ENTITIES OPERATE. THE PLAN, ANY AMENDMENTS THERETO, AND THE MEMBERS OF THE GAMING COMPLIANCE COMMITTEE, ONE SUCH MEMBER WHO SHALL BE INDEPENDENT AND KNOWLEDGEABLE OF THE ACT AND REGULATIONS, SHALL BE ADMINISTRATIVELY REVIEWED AND APPROVED BY THE CHAIR OF THE NGCB OR THE CHAIR'S DESIGNEE. AND ITS AFFILIATED COMPANIES.

- (3) MOHEGAN SUN CASINO LAS VEGAS SHALL ENSURE ALL SIGNS CONCERNING THE RACE BOOK AND SPORTS POOL, ALL WAGERING TICKETS AND BETTING SHEETS, HOUSE RULES, AND THE HOME PAGE OF ANY WEBSITE OR MOBILE APP PROMINENTLY INDICATE THAT MOHEGAN SUN CASINO LAS VEGAS IS THE OPERATOR OF THE RACE BOOK, SPORTS POOL, AND OFF-TRACK PARI-MUTUEL RACE WAGERING, AS THE CASE MAY BE. Hello. My name is Diamante Asberry, here on behalf of the Culinary Union.

We've spoken previously about Station Casinos' MUD lists. These were lists of workers, prepared by management, requested by an executive VP, indicating which workers were "pro-management," "pro-union," or "don't know." When rehiring workers, it is against the law to discriminate based on union preference.

The company started using MUD lists in 2019. On June 13, 2020 during the pandemic, the Chief Operating Officer of Red Rock Resorts wrote to General Managers, "Please send Phil and I your MUD lists from FR, Texas, FH and Palms. Also, please resend your open positions requested sheets." Why would the Chief Operating Officer ask for MUD lists and open position requests at the same time?

Three weeks earlier, on May 21, 2020, the Chief Operating Officer wrote to managers at closed Stations properties, "All, we may need to hire additional IM Team members to assist at the 6 open properties. Can I get Joel, Chris and Jordan to review the FT IM Team Members that were let go at your properties. We need a list of the most Company positive ones that we would want to offer a position at one of the six."

For what *legitimate* reason did Station Casinos create MUD lists to keep track of which employees were promanagement and which employees were prounion? And why would a chief executive request copies of MUD lists along with lists of open positions that need to be filled? Again, it is illegal to take into consideration a worker's attitude towards the union when making decisions to hire, recall, or transfer workers. That's one reason why the federal government has issued a complaint against Station alleging violations of federal law.

We believe that the use of MUD lists violates the company's Code of Business Conduct and Ethics, and we are once again asking for a comprehensive investigation into the company.

My name is Maria Espinoza. I have worked for Palace Station in the sanitation department for 18 years.

I am a committee member for the Culinary Union. I am making it known that this company does not respect my rights as a worker. I go to work even when I am not feeling well. I am afraid I may lose my job.

They terminated workers during the pandemic, and now they have re-hired some of us as new employees. I believe some of those re-hires are a lower salary and don't have their seniority.

They closed 3 properties and put those workers out of their jobs. And in my job, it feels like raises are not given equally.

We want you to help us. We have worked hard, and we want better from the company.

Despidieron trabajadores durante la pandemia, y ahora nos han vuelto a contratar a algunos de nosotros como nuevos empleados. Creo que algunos de los recontratados tienen un salario más bajo y no tienen su antigüedad.

Cerraron 3 propiedades y sacaron a esos trabajadores de sus trabajos. Y en mi trabajo, parece que los aumentos no se dan por igual.

Queremos que nos ayude. Hemos trabajado duro y queremos algo mejor de la compañía.
