PUBLIC COMMENTS AND DISCUSSION:

Comments taken from Member Watkins welcoming Chairman Hendrick and Member Assad to the Board. Additionally, Member Assad commented on his appointment to the Board and his commitment to serve the State.

My name is Robin Guevara, and I work at Red Rock Resort. I'm a bar porter. I have been with Station Casinos for seven years.

I feel like the company is unfair with us. Two years ago they gave some employees a raise, but they told us that if we make tips we were not going to get a raise. On top of us not getting a raise, our tip compliance went up. They told us we were going to get a bonus at the end of the year depending on our job performance, somewhere between 200 to 800 dollars. Now, two years later, they took our bonus away, and they said we were going to get a raise depending on our job performance. My coworkers and I don't feel like these raises were given fairly. I personally got a 32 cent raise. I don't feel like they value us.

The company holds meetings that exclude union workers, and they offer non-union workers different benefits. I feel like they are trying to divide us. I feel excluded and discriminated against for being part of the union.

I'm fighting for a union contract because I want fairness for myself and my coworkers. I want job security. Right now, I feel like I'm just a number to them. I want to feel like we matter.

Thank you.

Hello. My name is Diamante Asberry, here on behalf of the Culinary Union.

We've spoken previously about Station Casinos' MUD lists. These were lists of workers, prepared by management, requested by an executive VP, indicating which workers were "pro-management," "pro-union," or "don't know." When rehiring workers, it is against the law to discriminate based on union preference.

The company started using MUD lists in 2019. On June 13, 2020 during the pandemic, the Chief Operating Officer of Red Rock Resorts wrote to General Managers, "Please send Phil and I your MUD lists from FR, Texas, FH and Palms. Also, please resend your open positions requested sheets." Why would the Chief Operating Officer ask for MUD lists and open position requests at the same time?

Three weeks earlier, on May 21, 2020, the Chief Operating Officer wrote to managers at closed Stations properties, "All, we may need to hire additional IM Team members to assist at the 6 open properties. Can I get Joel, Chris and Jordan to review the FT IM Team Members that were let go at your properties. We need a list of the most Company positive ones that we would want to offer a position at one of the six."

For what *legitimate* reason did Station Casinos create MUD lists to keep track of which employees were pro-management and which employees were pro-union? And why would a chief executive request copies of MUD lists along with lists of open positions that need to be filled? Again, it is illegal to take into consideration a worker's attitude towards the union when making decisions to hire, recall, or transfer workers. That's one reason why the federal government has issued a complaint against Station alleging violations of federal law.

We believe that the use of MUD lists violates the company's Code of Business Conduct and Ethics, and we are once again asking for a comprehensive investigation into the company.
