Good morning. ~~Dispute Agency~~ for the Culinary Union. Last week Mr. Robert Cashell was before the board and commission. We gave this comment to the board only and want to give it to the commission now.

As we have told you before Red Rock Resorts Inc. and that company is an outlier in Nevada. It has the only all white, all male board among Nevada publicly traded gaming companies.

The same five white men have served on the Red Rock Resort board since its IPO in 2016 with its three independent directors including Mr. Cashell serving the board of Red Rock Resorts' predecessor company since 2011.

The first purpose of Red Rock Resorts' Nominating and Corporate Governance Committee charter is the identification, screening, review, and recommendation of qualified individuals for the board. Mr. Cashell is the chairman of that committee.

A diverse board is the standard in Nevada. So today we request you ask Red Rock Resorts and Mr. Cashell how many women and people of color has the all white, all male board recommended for nomination since its IPO? Is it zero?

Wall Street's NASDAQ and Goldman Sachs have said diverse boards are better positioned for improved corporate governance. The Philadelphia Board of Pensions & Retirement has filed a 2023 stockholder proposal with Red Rock Resorts regarding board diversity that would require the company to prepare a report on steps it is taking to enhance board diversity.

We urge you to tell Mr. Cashell today that Nevada's workers deserve board members who value board diversity and who uphold board charters.

My name is Eligio Jiminez. I am a Bartender at Sunset Station. I have been at Sunset Station since it opened in 1997.

At my casino, if you don't use vacation time by your anniversary date, you lose it. Last year the company denied the time off I requested in May. I was also denied the pay for those days.

This year I believe the company will deny my request to cash out my vacation days again because I am represented by the union.

In December the union agreed that the company should give enhanced benefits like paid time off conversion to ALL workers at Sunset Station.

Sunset has not agreed.

The company said that only non-union employees are eligible for the enhanced benefits.

I feel disappointed by the company. I've been at Sunset Station for 26 years. This is the second year in a row I could lose my vacation time that I earned. The pay I lost from my vacation time last year hurts. I have a son that I'm putting through college right now.

My coworkers and I work hard. We deserve our benefits. It's not fair for the company to deny them from us. We need a union contract at Sunset Station so the company can't do this to us.
