DIVISION REPORT

PUBLIC COMMENTS AND DISCUSSION: Chair Hendrick thanked Commissioner Markantonis for attending.

Good morning. Diamante Asberry, here on behalf of the Culinary Union. Employee benefits are vital to the everyday life of gaming workers and their families. And a holder of a Nevada gaming license should not discriminate against employees when it comes to benefits.

We've previously spoken to you about how Station Casinos discriminates against employees by denying benefits to some while providing benefits to others. Last December, the Culinary Union agreed as the elected representative for a bargaining unit of workers that Station Casinos should give a set of new enhanced benefits to all represented workers at Sunset Station, Green Valley Ranch, and Red Rock Casino. But the Company still has not done the right thing, and has just given the new benefits to non-union workers.

Under Stations' enhanced benefits, which went into effect in January of this year, full time team members who have worked for the company for at least six months are eligible for up to 6 weeks of paid time off following the birth or adoption of a child. But the catch is, you do not qualify for the benefit if you're in a job that is represented by a union.

Right now, there is a hostess cashier from the Lucky Penny at Red Rock who was denied the 6-week paid parental leave she applied for in April. She has worked for the company for 8 years. She is currently at home with her newborn baby, on an unpaid leave from work through FMLA. In May the company refused to give her paid leave to care for her child, which has caused her avoidable financial stress.

Her story is not unique. Workers across different Station Casinos properties have been denied enhanced benefits this year due to their union status.

We are once again asking you to tell Station Casinos to respect workers and to provide enhanced benefits without discrimination. Thank you.

Hello. My name is Dulce Valladares. I have worked for Station Casinos for 6 years. Before the pandemic, I worked as a full-time cook's helper at The Feast Buffet at Sunset Station.

With the pandemic closure in 2020, we were told that the buffet was not going to reopen, and that we were laid off and out of a job. The company later hired me for a new position as a cook, but with lower pay. I also don't have the same seniority as I did before the pandemic.

I feel like there are not enough workers at my job, and that hurts me. When I am the only cook during busy times, I have to work faster, and I can get hurt. I sprained my ankle at work in December last year.

I want my seniority back. I want a fair workload. I want Stations to respect the workers who have worked for them for years.
