Good morning. Diamante Asberry, here on behalf of the Culinary Union.

Employee benefits are vital to the everyday life of gaming workers and their families. And a holder of a Nevada gaming license should not discriminate against employees when it comes to benefits.

We've previously spoken to you about how Station Casinos discriminates against employees by providing certain enhanced benefits to some workers that it denies to others. I'm here today to let you know that the company continues to exclusively provide its enhanced benefits, which went into effect in January of this year, to its non-union workers while withholding these benefits from its union workers. Station Casinos' refusal to do the right thing causes workers and their families avoidable hardship.

One of these enhanced benefits is family support in the form of insurance continuation. This means that in the event of a Team Member's passing, their family members will remain covered by that Team Member's medical, dental, and vision insurance for 6 months.

Team Members represented by labor unions are not included in this program, or any other aspect of Station Casinos' enhanced benefits. This means that if you're in a Station Casinos job that's represented by a union and you die, your family members don't qualify for continued insurance coverage.

This is the reality. Workers across different Station Casinos properties have been denied enhanced benefits this year due to their union status.

Culinary Union agreed back in December 2022 that Station Casinos should give the enhanced benefits to ALL workers at Sunset, Green Valley Ranch, and Red Rock Casino, including the workers in the union bargaining unit. Those properties could have given all workers the enhanced benefits anytime this year, but have refused.

Station Casinos is discriminating against unionized workers, and we are asking you again to tell them to stop this discrimination and to offer all of its benefits to workers on an equal basis. Thank you.

My name is Mercedes Cabrera. I have worked as a kitchen worker at Green Valley Ranch for 17 years.

I have 3 siblings who are union members and I know all the benefits they have, such as good health insurance and a pension. I am fighting for a contract at Station Casinos because I want myself and my coworkers to have the same, because we are not second class workers. We deserve respect!
