Mr. Kreeger's March 2022 employment agreement with Station Casinos' parent company states that it is his responsibility "to devote his full time and attention to the business and affairs of the Company and shall use his best efforts, skills and abilities to promote the interests of' Red Rock Resorts Inc. and Station Casinos.

So today we want to ask Mr. Kreeger to address the Company's practice of discriminating against union workers when it comes to benefits.

Under Stations' enhanced benefits, which went into effect January of this year, Team Members are entitled to things like paid parental leave, 6 months of continued insurance coverage for their families after death, and the ability to cash out paid time off hours. But the catch is, you do not qualify for these benefits if you're in a job that is represented by a union. To clarify, this means that if you're in a Station Casinos job that's represented by a union and you give birth to a child, you don't qualify for paid time off to care for that child. If you're in a Station Casinos job that's represented by a union and you die, your family members don't qualify for continued insurance coverage.

Mr. Kreeger may say, as company documents claim, that workers represented by the union are not eligible for the enhanced benefits due to the company's legal obligation to bargain with the union about benefits. However, last December, the Culinary Union agreed as the elected representative for a bargaining unit of workers that Station Casinos should give a set of new enhanced benefits to all represented workers at Sunset Station, Green Valley Ranch, and Red Rock Casino. Station Casinos could have given those benefits to all workers at any time. But the Company still has not done the right thing, and has just given the new benefits to non-union workers at those properties.

Today we ask Mr. Kreeger to go on the record stating whether he thinks Station Casinos should stop discriminating against its workers and provide enhanced benefits equally to all Team Members.



Good morning. Briana Carbajal for the Culinary Union. I want to comment on a couple questionable text messages by a Station Casinos property general manager in 2020 and ask if the current president of the company, Mr. Kreeger, believes it is right or wrong for management to violate workers' rights and federal labor law.

An employer like Station Casinos violates the National Labor Relations Act by encouraging, promoting, or providing assistance to employees seeking to decertify their union. Very simply, workers vote in a union and then workers can vote out the union, but management cannot encourage, promote or assist.

The two questionable text messages come from the general manager of Palace Station in 2020 where the company had recognized the workers as unionized. The first text message refers to management help with the decertification. The Palace general manager says the corporate director of human resources instructed him to get a list of people who can help decertify the union. On January 11, 2020, Dave Horn, the GM of Palace Station, texted a colleague: "Phil says to get me the names of the people who can help with decertification but don't get directly involved."

Nine months later the same Palace Station general manager writes about how his involvement in completing the decertification came at a personal cost. "I got the dertification of the Union completed," Horn texted a colleague on September 22, 2020. "We submitted to them yesterday. Fucking lost part of my life in taht process. Craziest deal ever." The colleague responded "Awesome, congratulations! You have to be approaching golden boy status." Dave Horn, referred to as "golden boy status," is now the general manager of Durango Station.

Station Casinos management violates federal labor law by encouraging, promoting, or providing assistance to employees seeking to decertify their union. So today we ask Mr. Kreeger to simply go on the record stating what he believes a Station Casinos general manager meant when he text "I got the decertification of the Union completed." Is that an admission of violating federal labor law or is it not? And we urge the board to ask him that simple question today. Thanks.

Team Members represented by labor unions are not included in these programs due to the fact that we are required by law to work through those unions as their authorized bargaining representatives – and we are in the process of doing so. Good morning. My name is Rory Kuykendall. I'm a bellman at the Flamingo and currently on a leave of absence working as a researcher at the Culinary Union.

Red Rock Resorts Inc. is the parent company of Station Casinos. And I want to comment on Mr. Kreeger's responsibility as president of the Red Rock Resorts Inc and what we believe that responsibility requires him to do about Station Casinos' MUD Lists.

Mr. Kreeger's March 2022 employment agreement with Station Casinos' parent company states that it is his responsibility "to devote his full time and attention to the business and affairs of the Company and shall use his best efforts, skills and abilities to promote the interests of" Red Rock Resorts Inc. and Station Casinos.

Today we are asking Mr. Kreeger to use his efforts, skills and abilities to address the harm done to our community by Station Casinos' MUD Lists.

Station Casinos executives ordered supervisors to create M.U.D. Lists since 2019 to keep track of which employees were pro-management (M), pro-union (U), or don't know (D). The company then used the information in deciding which workers to rehire following the COVID-19 pandemic. The Culinary Union has counted 2,261 names of employees that appeared on MUD Lists from Station properties in 2020.

It is illegal for an employer to discriminate based on union preference when hiring workers. Using MUD lists in employment decisions is a violation of federal law.

So today we ask Mr. Kreeger to simply go on the record stating whether Station Casinos putting any person from our community on a MUD List was right or wrong.

Mr. Kreeger may suggest the MUD Lists were before his time at the company and that the MUD Lists are part of ongoing proceedings before the National Labor Relations Board. However, the president of the company should be able to answer whether it was right or wrong for the company to put its employees on MUD Lists. And we encourage the board to ask him that simple question today. Thanks. My name is Barbara Lee Tivas.

I worked at Green Valley Ranch Hotel and Stations Casino since April of 2007. I was a full-time Banquet server for GVR.

I was also on the campaign to unionize GVR and negotiate a fair contract. We won our election! But Stations Casinos has never agreed to a collective bargaining agreement.

For 14 years, I was part of a family of workers that had many of the same issues and concerns in common. We all wanted to provide for our families. Work hard, take vacations when needed, plan for a retirement with dignity. Many union members have this common goal achieved.

As a collective, we made sure that Station Casinos was successful. All of that changed when the Covid pandemic hit. The company closed its doors like many companies did. The only difference is, Green Valley Ranch re-opened in June of 2020. Having only been closed for a few months, I thought for sure they would start calling us back to work. Boy were we wrong. We all had to ask, Did this consortium use the pandemic to relieve themselves of having to negotiate with workers for a fair contract? Since I was instrumental in unifying workers to unionize, was this the reason I was not called back?

The company did recover financially, with the help of locals returning to the casinos. They have recovered, and then some, using their resources to open a new Durango Station. Many unrepresented workers, including myself, went to lawmakers in Carson City, to make Stations Casinos do the right thing and get Right to Return laws implemented.

Why wouldn't they just hire everyone back? It is not right that we as workers continue to struggle.

I have never received a call back. I went to a job fair, at GVR, where I worked for years. I had a fresh resume, new haircut, and my head held high. When myself and other laid off workers arrived, the line had already begun to grow. We were servers that had arrived to claim our jobs back.

I stayed strong and smiled through the heartbreak of feeling cast aside by the company I was so loyal to. They asked the standard questions like: How are you a

good fit for the company? And what skills can you bring to stand out against other applicants? I answered their questions and had a great interview. These questions make sense for a new applicant, but for myself, I found it degrading. To be forced to sell myself to the company again was a slap in the face.

What they know but seem to forget, my job was more than a job. It was my identity, my future builder, my stability. So now, I work odd jobs, hovering over the Vegas Valley waiting for the chance to have my dignity returned. Waiting for "my" Recall Rights that might never come.

I am suffering from chronic Ulcerative Colitis and depression since the company fired me. I am grateful to be alive to address this board and Mr. Kreeger today. Workers are human beings who are not garbage to be tossed away.

A union contract would have protected my job and thousands of others.

My job is probably lost to the greed and arrogance of this company. So, I'm here on behalf of those that currently work for the company and get mistreated daily.

We are asking that you as a board be our allies.

Please use your voice to show the support you have for all of us forgotten workers.

Please use your voice to tell Station Casinos that workers have rights.

Please, Pause the madness of Stations' greed and give workers a voice....

Please, Be a part of our community coalition against companies that do harm.

Please, Support our efforts to protect future generations from harm.

We have a legal right to have a contract now, we are asking that the company honors our rights as workers!

Good morning. My name is Robert Franz. I am here today to tell you about my experience working at Red Rock Casino and why I believe we need to have a union and a union contract there.

I started working at Red Rock as a banquet server back in November 2006. I worked there for 14 years, and I worked my way up from on-call to full-time. Full-time meant that I was scheduled first when events were booked. I was loyal to the company and passed on opportunities to go work at new properties such as Resorts World and Caesars Forum. I even bought a house near Red Rock.

In 2020, everything changed. When Red Rock reopened after the shutdown, I was not brought back to work despite my years of service and excellent performance over the years. Instead of bringing me back, they hired new people in the banquet department who had no experience with the company. I was told to interview for my old job, and I was not offered the job. I was eventually rehired in the summer of 2021, but I lost all my seniority, and I would only be working on-call. Now I have to compete with other banquet workers for work despite my 14 years with the company before 2020.

I have represented my coworkers as a union committee person since late 2018. I knew back then that we need to have a union and a union contract to protect our jobs. That's why I am still fighting for a union contract at Red Rock. It is not fair what this company did to me and other workers who never got their jobs back.
