PUBLIC COMMENTS

This public comment agenda item is provided in accordance with NRS 241.020(3)(d)(3) which requires an agenda provide for a period devoted to comments by the general public, if any, and discussion of those comments. No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action will be taken. Comments by the public may be limited to three minutes as a reasonable time, place and matter restriction, but may not be limited based upon viewpoint.

PUBLIC COMMENTS AND DISCUSSION: Chair Hendrick thanked Commissioner Markantonis for attending.

Good morning. Diamante Asberry, here on behalf of the Culinary Union.

I'm here today to talk to you about Palace Station management's relationship with workers.

It is a violation of the National Labor Relations Act for a company to encourage, promote, or provide assistance to employees seeking to decertify their union. Very simply, workers vote in a union and then workers can vote out the union, but management cannot encourage, promote or assist.

Questionable text messages referring to management involvement with the decertification of the union at Palace Station were exchanged between Station Casinos management in 2020 during the time period when the company had recognized Palace Station workers as unionized.

On January 11, 2020, Dave Horn, the GM of Palace Station, texted a colleague: "Phil says to get me the names of the people who can help with decertification but don't get directly involved."

And it was not just at Palace Station. On June 25, 2020, the Sunset Station GM asked the Station Casinos head of HR "How do I get information on attending one of the decertification meetings?"

According to Palace Station sanitation workers, management's relationship with workers has been openly hostile.

One sanitation worker wrote an incident report about her manager yelling in her face on November 28, 2022. She then filed another report to the company on January 16, 2023 about this same manager yelling and confronting her aggressively for taking time off for FMLA. In a June 28, 2023 incident report she wrote, "I am very frustrated in the fact that I have made multiple reports and no action is being taken against [manager]." She also wrote, "He's told me that no matter how many times I report him, that nothing will happen."

Another sanitation worker wrote in a letter to Palace Station executives, "The sanitation supervisors cause a hostile environment at work by having favorites and treating my other coworkers unequally and unfairly." She also said, "I know if you know what was going on inside our department you would not support the actions being taken against Station employees who have been loyal to the company."

We believe that when a company violates labor law and when workers from a sanitation department feel threatened, it harms the reputation of the Nevada Gaming Industry as a whole. We ask you to help hold Station Casinos accountable for what has happened at Palace Station.

Muchos de mis compañeros de trabajo en Palace Station han renunciado o han sido despedidos por la compañía. Y parece que mis compañeros que siguen aquí están estresados y se enferman más frecuente.

Despidieron trabajadores durante la pandemia, y ahora nos han vuelto a contratar a algunos de nosotros como nuevos empleados. Creo que algunos de los recontratados tienen un salario más bajo y no tienen su antigüedad.

Cerraron 3 propiedades y sacaron a esos trabajadores de sus trabajos. Y en mi trabajo, parece que los aumentos no se dan por igual. Parece que la gerencia divide a los trabajadores.

Queremos que nos ayude. Hemos trabajado duro y queremos algo mejor de la compañía. Queremos un contrato. Queremos seguridad laboral. Queremos respeto.

My name is Maria Espinoza. I have worked for Palace Station in the sanitation department for 20 years.

I am a committee member for the Culinary Union. I am making it known that this company does not respect my rights as a worker. I go to work even when I am not feeling well. I am afraid I may lose my job. I want a contract to secure my job.

A lot of my coworkers at Palace Station have quit or been fired by the company. And it seems like my coworkers who are still here are stressed and they get sick more often.

They terminated workers during the pandemic, and now they have re-hired some of us as new employees. I believe some of those re-hires are a lower salary and don't have their seniority.

They closed 3 properties and put those workers out of their jobs. And in my job, it feels like raises are not given equally. It feels like management divides the workers.

We want you to help us. We have worked hard, and we want better from the company. We want a contract. We want job security. We want respect.

I want to speak about the Fontainebleau Resort, which is item 3-11-23 on today's agenda, and which is scheduled to open on December $13^{\rm th}$.

Before you evaluate the application of the Fontainebleau (and related entities Bowtie Hospitality, Mr. Jeffrey Soffer and Mr. Brett Mufson), we urge you to consider the suitability of a project that could bring a labor dispute to the north end of the Las Vegas Strip.

The Teamsters Union has asked Fontainebleau Development to enter into an agreement that respects workers' rights and allows for labor peace on the Las Vegas Strip, which it has already entered into with the Culinary Union (UNITE HERE Local 226). The Teamsters expect the same agreement for our traditional jurisdiction in Las Vegas.

Although there were initial communications with Fontainebleau Development about this, they have become completely unresponsive for months despite repeated attempts to continue discussions on our part.

Without such an agreement, there will be a labor dispute at the Fontainebleau including picket lines on opening day and continuing afterwards.

Given our decades-long relationship with the Culinary Union, we expect that they will honor our picket lines.

This dispute will not be limited to the Fontainebleau. At the Gaming Control Board hearing on July 12th for his "preliminary finding of suitability," Mr. Soffer indicated his intention to establish a partnership with the Convention Center and press accounts indicate that the Fontainebleau ultimately plans to build a structure that connects the Fontainebleau to the West Hall of the Convention Center. Any future labor dispute could impact the Convention Center, whose workers are also represented by the Teamsters Union.

We also believe that the Fontainebleau will focus on next February's Super Bowl, given Mr. Soffer's long-standing relationships with the NFL and its leadership and players, especially Tom Brady:

- Tom Brady is a close personal friend of Mr. Soffer.
- Tom Brady is believed to be opening a shop inside the Fontainebleau Las Vegas.
- Fontainebleau Development is currently building Mr. Brady's new home located at 26 Indian Creek Island Road. Mr. Soffer's home address is 27 Indian Creek Island Road.
- Mr. Soffer recently won the development rights to build a hotel project at Miami International Airport. His partner is Stephen Ross, owner of the Miami Dolphins.

We believe this issue is relevant to your deliberations about the suitability of the Fontainebleau for a gaming license. As you consider the Fontainebleau's application, please consider the impact that a labor dispute could have on the northern end of the Las Vegas Strip.

Good morning. Alan Morales from the Culinary Union.

A gaming license holder like Paris Casino is a landlord with third party tenants. Paris Casino as the landlord and gaming license holder is required by Nevada law to ensure third party tenants follow rules, regulations and laws. Workers in third party restaurants need the landlord to hold restaurant tenants accountable.

Casino licensees are responsible for the conduct of their tenants and accountability to adhere to rules, regulations, and laws according to NRS 463.0129 and GBC 5.010. This includes misconduct that falls under the enforcement of the Gaming Control Board.

Example 1: Water on the floor inside a kitchen area. On August 16, 2023, a video shows multiple workers standing in water as well as on wet cardboard in the kitchen area at Alexxa's Kitchen and Bar. Alexxa's is a restaurant by JRS Hospitality. While workers were cleaning up, meal prep continued in the area: employees were active in the area where water was.

Example 2: Fire. On May 10, 2023, the Fire Department was called inside Paris due to a fire in the same restaurant Alexxa's Kitchen and Bar. Caesars is responsible as the landlord to make sure that Alexxa's follows OSHA standards and keeps all individuals on the property safe.

Example 3: Violence towards customers and employees. In December 2021, an employee was stabbed at Paris, near Mon Ami Gabi, a Lettuce Entertain You restaurant. The incident from the Police Department states:

The male followed the victim to the bathroom and stabbed one of the bathroom doors then told the victim to get on his knees. The suspect swung the knife at the victim and the victim got cut above the left eyebrow.

Before this attack, the male had followed a female employee into Paris and spent time in a kitchen. The person was able to enter Caesars' property by raising his hand when seeing the security officer and he "simulated scanning his badge."

On July 4, 2022, according to the police report, an individual "approach[ed] customers sitting on the stairs outside of the restaurant and spit on them." Then, picked up a butter knife off the table and stated, "I'm going to kill you" and charged at the victims.

Public confidence and trust are key to the success of gaming establishments. Employees, customers and all of us in Las Vegas need to be able to trust Caesars Entertainment and Paris Casino as the landlord for restaurant tenants to ensure safe conditions at all of their properties.
