POSSIBLE AMENDMENTS TO NGC REGULATION 14 — MANUFACTURERS, DISTRIBUTORS, OPERATORS OF INTER-CASINO LINKED SYSTEMS, GAMING DEVICES, NEW GAMES, INTER-CASINO LINKED SYSTEMS, ON-LINE SLOT METERING SYSTEMS, CASHLESS WAGERING SYSTEMS AND ASSOCIATED EQUIPMENT.

(Possible Action)

PURPOSE: To amend provisions of Regulation 14 and specifically, 14.010(6), 14.010(14), 14.170, 14.180 and 14.190 to conform to the Nevada Gaming Control Act as amended by Assembly Bill 294 of the Seventy-Sixth Regular Session of the Nevada Legislature; providing for applications, recordkeeping and procedures for extraterritorial distribution of gaming devices based on operational differences in licensees; clarifying requirements for distribution by licensees other than manufacturers and distributors licensed by the commission; and providing other matters properly related thereto.
