SUBJECT: Regulations 6.010 and 6.080 – Posting of Annual Threshold Amounts for Group I and II Nonrestricted Licensee Definitions and for Submission of Audited/Reviewed Financial Statements

A statutory change, SB 9 effective June 3, 2013, included a revision to NRS 463.159(3), in allowing the Board, rather than the Commission, to adjust the annual threshold amounts used to determine which nonrestricted licensees are subject to audits of financial statements and which are subject to reviews of financial statements. Pursuant to Regulation 6.010 (7), a similar adjustment was made relating to the gross revenue threshold amounts defining Group I and Group II nonrestricted licensees.

On October 24, 2013, the Nevada Gaming Commission approved the adoption of amended Regulations 6.010 and 6.080, in line with the statutory change, indicating that the Board shall post such annual amounts on its website no later than December 15 preceding the fiscal year for which such amounts shall be effective.

The threshold amounts indicated in the below table are for Regulations 6.010 and 6.080 and have been calculated based on a consumer price index ("CPI") adjustment of 2.1%. The revisions to Regulation 6.080 will be effective January 1, 2014, while the changes to Regulation 6.010 will be effective July 1, 2014.
