2020-07R: CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 22.080 REGARDING, WITHOUT LIMITATION, DETERMINATION ON THE OUTCOME OF WAGERS FOR HORSE AND OTHER ANIMAL RACES.

**PURPOSE**: To consider extending or removing the sunset provision for the Regulation 22.080 language adopted by the Commission on August 27, 2020; to allow a licensed race book to determine the outcome of wagers for horse or other animal races based on information received from sources other than a disseminator; and to take such additional action as may be necessary and proper to effectuate this stated purpose.
