2021-02RP: CONSIDERATION AND RECOMMENDATION TO NEVADA GAMING COMMISSION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 5.225 REGARDING, WITHOUT LIMITATION, AMENDING THE DEFINITION OF "WAGERING ACCOUNTS."

**PURPOSE**: To amend Nevada Gaming Commission ("Commission") Regulation 5.225(1)(d) to clarify that the term "wagering account" does not mean an electronic ledger used solely to record and track wagering vouchers whose validity and value are determined, monitored, and retained by a licensee's cashless wagering system and/or to communicate with a licensee's cashless wagering system to facilitate a patron's use and redemption of the stored and tracked wagering vouchers; To add a reference to the definition of "wagering voucher" found in the Nevada Revised Statutes; To reformat the subsection to conform with current drafting standards used by the Commission; To replace the term "accounts" with "electronic ledger" in the existing exemption for clarification purposes; And to take such additional actions as may be necessary and proper to effectuate this stated purpose.
