AMENDMENT NO. 4 TO ORDER OF REGISTRATION

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, are hereby accepted as filed:

a. The application of AES Technology Systems, Inc., for an amendment to its Order of Registration, to become a controlling stockholder of Interscience Systems, Inc.

b. The applications of the following entities to be found suitable as security holders of AES Technology Systems, Inc.:






