AMENDED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board at Carson City on August 15, 1973, and before the Nevada Gaming Commission at Carson City on August 23, 1973 on the application of the Chief of Securities, and

WHEREAS, Karat, Inc., a Nevada corporation and Fremont Hotel, Inc., a Nevada corporation are licensees under the Nevada Gaming Control Act and are solely owned subsidiaries of Fremont Holding Corp., a Nevada corporation, and Fremont Holding Corp., is a solely owned subsidiary of Recrion Corporation, Registrant herein and whereas Registrant was heretofore found to be suitable to be a holding company of the hereinabove-mentioned holding company and Corporate Licensees and pursuant to such findings of suitability was registered as a publicly traded corporation, pursuant to the Nevada Gaming Control Act; and

WHEREAS, on May 24, 1973 the Nevada Gaming Commission adopted Regulation 16 "Public Traded Corporations", pursuant to the provisions of the said Nevada Gaming Control Act, which Regulation is scheduled to become effective on September 1, 1973; and

1 WHEREAS, Registrant has consented to the making and enter-
2 ing of this Order.

3 NOW THEREFORE, in accordance with the information currently
4 on file with the State Gaming Control Board it is now hereby
5 ordered by the Nevada Gaming Commission, upon the recommendation
6 of the State Gaming Control Board;

7 1. That Recrion Corporation has previously been found
8 suitable to be a holding company of Fremont Holding Corp., Karat,
9 Inc., and Fremont Hotel, Inc., Nevada corporations; Karat, Inc.,
10 and Fremont Hotel, Inc., being the Corporate Licensees, and such
11 finding is hereby reaffirmed; and Recrion Corporation is hereby
12 found suitable to be a holding company of Fremont Holding Corp.;
13 Karat, Inc., and Fremont Hotel, Inc., Corporate Licensees.

14 2. That Recrion Corporation is registered pursuant to the
15 provisions of the Nevada Gaming Control Act and the regulations
16 thereunder, as a publicly traded corporation.

17 3. That pursuant to NRS 463.625,2, Recrion Corporation has
18 been and hereby is reaffirmed to be exempted from compliance
19 with NRS 463.585 to NRS 463.615, inclusive; and Regulation 15,
20 and instead, is hereby Ordered to comply with NRS 463.635 to
21 NRS 463.641, inclusive; and Regulation 16.

22 4. That this Amended Order of Registration shall be
23 effective at 12:01, A.M., September 1, 1973.
