EIGHTH REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on September 10, 1997, and before the Nevada Gaming Commission ("Commission") on September 25, 1997, at Las Vegas, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, have been filed:

a. The application of American Wagering, Inc. for an amendment to its Order of Registration; and

b. The applications of Leroy's Horse and Sports Place for licensure to conduct off-track pari-mutuel sports wagering and nonrestricted gaming operations (race book and sport pool only) at the following locations; Fitzgeralds Casino/Hotel Race & Sportsbook, 255 North Virginia Street, Reno; and The Golden Gate, 1 East Fremont Street, Las Vegas.

2. THAT the Seventh Revised Order of Registration, dated June 19, 1997, is hereby amended and restated, in its entirety, by this Eighth Revised Order of Registration.

3. THAT American Wagering, Inc. is registered as a publicly traded corporation and is found suitable as the sole shareholder of Leroy's Horse and Sports Place and Computerized Bookmaking Systems, Inc.

4. THAT American Wagering, Inc. is approved, pursuant to NGC Regulation 16.200, to acquire control of B-P Gaming Corporation.

5. THAT American Wagering, Inc. is found suitable as the sole shareholder of B-P Gaming Corporation.

6. THAT Computerized Bookmaking Systems, Inc. is registered as an intermediary company and found suitable as a 50% shareholder of Megasports Inc. provided, that Computerized Bookmaking Systems, Inc. shall have no further direct or indirect expansion of the relationship with Hipodromo de Aqua Caliente, S.A. de C.V, or its affiliates.

7. THAT Megasports, Inc. is licensed as a systems operator for off-track pari-mutuel sports wagering, subject to such conditions or limitations as may be imposed by the Commission.

8. THAT Leroy's Horse and Sports Place is licensed to conduct off-track pari-mutuel sports wagering and nonrestricted gaming operations (race book and sports pool only) at the following locations, subject to such conditions or limitations as may be imposed by the Commission:

9. THAT Leroy's Horse and Sports Place is licensed to conduct off-track pari-mutuel sports wagering and nonrestricted gaming operations (sports pool only) at the following locations, subject to such conditions or limitations as may be imposed by the Commission:

10. THAT Leroy's Horse and Sports Place, dba Leroy's Horse and Sports Place, is licensed to conduct off-track pari-mutuel race and sports wagering and nonrestricted gaming operations (slot machines, race book and sports pool only) at 3111 West Tropicana Avenue, Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

11. THAT Leroy's Horse and Sports Place is licensed to conduct off-track pari-mutuel sports wagering and the following nonrestricted gaming operations doing business at the following locations, subject to the conditions or limitations set forth below, and any other conditions or limitations as may be imposed by the Commission:

a. The licensee must comply with Nevada Gaming Commission Regulation 6.090 as it relates to the submission of an adequate internal control system and compliance with the minimum internal control standards for a computerized race book and sports pool.

b. Any change in any agreement or the creation of any new agreement between Leroy's Horse and Sports Place, and the licensed location, must be reported to the Board within 30 days of such change.

c. Funds between Leroy's Horse and Sports Place, and the licensed location, must not be commingled.

d. The ticket writers must be employees of Leroy's Horse and Sports Place.

e. The surveillance system must be installed, reviewed and administratively approved by the GCB Enforcement Division prior to issuance of a State Gaming License and thereafter be maintained at or above the standard which is approved.

12. THAT Victor John Salerno, Jr., is found suitable, pursuant to NRS 463.643, and NGC Regulation 16.400, as a shareholder and controlling shareholder of American Wagering, Inc.

13. THAT, pursuant to NGC Regulation 26B.190, the provisions of NGC Regulation 26B.040(4), as they relate to Megasports, Inc.'s licensure as an off-track pari-mutuel sports wagering systems operator, are hereby waived, subject to such conditions or limitations as imposed by the Commission.

14. THAT American Wagering, Inc. shall establish and maintain a compliance committee for the purpose of, at a minimum, performing due diligence, determining the suitability of relationships with other entities and individuals, and to review and ensure compliance by American Wagering, Inc., its subsidiaries and any affiliated entities, with the Nevada Gaming Control Act ("the Act"), as amended, the Commission's Regulations, as amended (the "Regulations"), and the laws and regulations of any other jurisdictions in which American Wagering, Inc., its subsidiaries and any affiliated entities operate. The compliance committee plan, any amendments thereto, and the members, one such member which shall be independent, shall be administratively reviewed and approved by the Chairman of the Board, or his designee. Furthermore, upon request of the Chairman of the Board, or his designee, American Wagering, Inc., shall amend the compliance committee plan, or any element thereof, and perform such duties as may be assigned by the Chairman of the Board, or his designee related to a review of activities relevant to the continuing qualification of American Wagering, Inc., under the provisions of the Act and Regulations.

15. THAT American Wagering, Inc. shall fund and maintain with the Board a revolving fund in the amount of \$10,000 for the purpose of funding investigative reviews by the Board for compliance with the terms of this Order of Registration. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities of American Wagering, Inc., its direct and indirect subsidiaries, and their affiliated companies.

16. THAT, pursuant to NRS 463.625, American Wagering, Inc. is exempted from compliance with NRS 463.585 through NRS 463.615, inclusive and shall instead comply with NRS 463.635 through 463.645, inclusive.

17. THAT American Wagering, Inc. is exempted from NGC Regulation 15 and shall instead comply with NGC Regulation 16.

18. THAT the Commission hereby expressly finds that the exemptions and waivers granted hereinabove are consistent with the State policy set forth in NRS 463.0129, NRS 463.489 and NRS 464.020, as applicable.
