AMENDMENT NO. 1 TO SECOND REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board on December 6, 1989, and before the Nevada Gaming Commission on December 21, 1989, at Las Vegas, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, are hereby accepted as filed:

a. The application of Mizpah Investments, Inc., dba Mizpah Casino, for a nonrestricted gaming license (slot machines only).

b. The application of APT Games, Inc. for a finding of suitability as the sole shareholder of Mizpah Investments, Inc., dba Mizpah Casino.

c. The application of United Gaming, Inc. for an amendment to its Second Revised Order of Registration.

2. THAT paragraph 4 of the Second Revised Order of Registration of United Gaming, Inc. entered on April 27, 1989, is hereby rescinded and superseded in its entirety, and the following language is hereby substituted in lieu thereof:

"4. THAT APT Games, Inc. is registered as an intermediary company and found suitable to be the sole shareholder of United Coin Machine Co., APT Coin Machines, Inc., and Mizpah Investments, Inc."

3. THAT paragraph 8 of the Second Revised Order of Registration of United Gaming, Inc. entered on April 27, 1989, is hereby rescinded and superseded in its entirety.

4. THAT paragraph 12 of the Second Revised Order of Registration of United Gaming, Inc. entered on April 27, 1989, is hereby rescinded and superseded in its entirety, and the following language is hereby substituted in lieu thereof:

"12. THAT United Gaming, Inc. shall fund and maintain with the State Gaming Control Board a revolving fund in the amount of \$5,000, for the purpose of funding investigative reviews by the Board for compliance with the terms of this Second Revised Order of Registration and any amendments thereto. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities, including public offerings, of United Gaming, Inc., United Coin Machine Co., APT Games, Inc., Mizpah Investments, Inc., APT Coin Machines, Inc., Casino Electronics, Inc., and their affiliated companies."

5. THAT the Second Revised Order of Registration of United Gaming, Inc.

entered on April 27, 1989, is hereby amended by adding thereto a new paragraph setting forth the following:

"THAT Mizpah Investments, Inc., dba Mizpah Casino, is licensed to conduct nonrestricted gaming operations (slot machines only) at 100 Main Street, Tonopah."

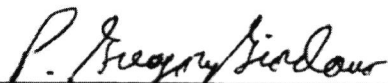

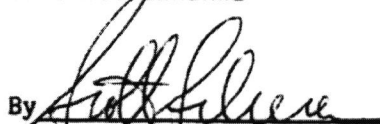
