SEVENTH REVISED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board ("Board") on December 6, 1995 at Carson City, Nevada, and before the Nevada Gaming Commission ("Commission") on December 21, 1995, at Carson City, Nevada; and

THE BOARD AND COMMISSION having considered all information pertinent hereto;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as amended and supplemented, of Station Casinos, Inc. have been filed:
  - a. For an amendment to its Order of Registration;
  - b. For a finding of suitability as the sole shareholder of Green Valley Station, Inc. and Green Valley Ventures, Inc.;
  - c. For an exemption from the requirements of NGC Regulations 16.100(1) and (2); and
  - d. For licensure as a manufacturer and distributor.

2. THAT the following applications, as amended and supplemented, of Green Valley Ventures, Inc., have been filed:

a. For registration as an intermediary company; and

b. For licensure as a 49.999% member of Town Center Amusements, Inc., a Nevada limited liability company.

3. THAT the following applications, as amended and supplemented, of Green Valley Station, Inc., have been filed:

a. For registration as an intermediary company; and

b. For licensure as a 50.001% member and manager of Town Center Amusements, Inc., a Nevada limited liability company.

4. THAT the following applications, as amended and supplemented, of Town Center Amusements, Inc., a Nevada limited liability company, dba Barley's Casino and Brewing Company, have been filed:

a. For registration as a Nevada limited liability company; and,

b. For licensure to conduct nonrestricted gaming activities, including a sports pool.

5. THAT the Sixth Revised Order of Registration, dated November 21, 1995, is hereby amended and restated, in its entirety, by this Seventh Revised Order of Registration.

6. THAT Station Casinos, Inc. is registered as a publicly traded corporation and is found suitable as the sole stockholder of Palace Station Hotel & Casino, Inc., Southwest Gaming Services, Inc., Boulder Station, Inc., Texas Station, Inc., Green Valley Ventures, Inc. and Green Valley Station, Inc., and is licensed as a manufacturer and distributor, subject to such conditions as may be imposed by the Commission.

7. THAT Frank J. Fertitta III, Blake L. Sartini, Delise F. Sartini, and Lorenzo J. Fertitta are each found suitable as a controlling shareholder of Station Casinos, Inc.

8. THAT Green Valley Ventures, Inc. is registered as an intermediary company and licensed as a 49.999% member of Town Center Amusements, Inc., a Nevada limited liability company.

9. THAT Green Valley Station, Inc. is registered as an intermediary company and licensed as a 50.001% member and manager of Town Center Amusements, Inc., a Nevada limited liability company.

10. THAT Town Center Amusements, Inc., dba Barley's Casino and Brewing Company, is registered as a Nevada limited liability company, and is licensed to conduct nonrestricted gaming operations, including a sports pool, at 4500 East, Sunset Road, Suite 30, Henderson, subject to such conditions or limitations as may be imposed by the commission.

11. THAT Palace Station Hotel & Casino, Inc., dba Palace Station Hotel & Casino, is licensed to conduct off-track pari-mutuel wagering and nonrestricted gaming operations, including a race book and sports pool, at 2411 West Sahara, Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

12. THAT Southwest Gaming Services, Inc. is registered as an intermediary company and is found suitable as the sole shareholder of Tropicana Caboose, Inc., and Nellis Caboose, Inc., and is licensed as a distributor and an operator of a slot machine route, subject to such conditions or limitations as may be imposed by the Commission.

13. THAT Tropicana Caboose, Inc., dba Loose Caboose Saloon, is licensed to conduct restricted gaming operations at 3175 East Tropicana, Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

14. THAT Nellis Caboose, Inc., dba Loose Caboose Saloon, is licensed to conduct nonrestricted gaming operations (slot machines only) at 15 North Nellis Boulevard, Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

15. THAT Boulder Station, Inc., dba Boulder Station Hotel & Casino, is licensed to conduct off-track pari-mutuel wagering and nonrestricted gaming operations, including a race

book and sports pool, at 4111 South Boulder Highway, Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

16. THAT Texas Station, Inc., dba Texas Gambling Hall & Hotel, is licensed to conduct off-track pari-mutuel wagering and nonrestricted gaming operations, including a race book and sports pool, at 2101 Texas Star Lane, North Las Vegas, subject to such conditions or limitations as may be imposed by the Commission.

17. THAT, Station Casinos, Inc. is granted approval, pursuant to NRS 465.510(1) and NGC Regulation 8.030, to pledge the common stock of Boulder Station, Inc., Palace Station Hotel and Casino, Inc., and Texas Station, Inc. to Bank of America, Managing Agent, in connection with the \$275,000,000 Senior Secured Reducing Revolving Credit Facility ("Credit Facility") provided that:

a. A Copy of the fully executed Pledge Agreement in the form of the draft dated July 5, 1995, must be filed with the Board;

b. The prior approval of the Commission must be obtained before any foreclosure or transfer of the possessory security interest in such common stock (except back to Station Casinos, Inc.) and before any other resort to such common stock collateral or other enforcement of the security interest in such common stock, may occur; and

c. Pursuant to NGC Regulations 15.510.1-3 and 8.030(4)(a), the common stock certificates of Boulder station, Inc., Palace Station Hotel and Casino, Inc., and Texas Station, Inc. evidencing said pledge of the common stock must at all times remain physically within the State of Nevada at a location designated to the Board and must be made available for inspection by agents or employees of the Board immediately upon request during normal business hours.

18. THAT, in conjunction with the Credit Facility and the Pledge Agreement, as applicable, Station Casinos, Inc. is granted approval, pursuant to NGC Regulations 15.510.1-4 and 15.585.7-3, as appropriate, to enter into an agreement with Bank of America, Managing

Agent, to place restrictions upon the transfer of, and agree not to encumber, the common stock of Boulder Station, Inc., Palace Station Hotel & Casino, Inc., and Texas Station, Inc.

19. THAT, in conjunction with the Credit Facility, Southwest Gaming Services, Inc. is granted approval, pursuant to NGC Regulation 15.510.1-4, to enter into agreement(s) with Bank of America, Managing Agent, to place restrictions upon the transfer of, and agree not to encumber, the equity securities of Nellis Caboose, Inc. and Tropicana Caboose, Inc.

20. THAT Station Casinos, Inc. shall fund and maintain with the Board a revolving fund in the amount of \$10,000 for the purpose of funding investigative reviews by the Board for compliance with the terms of this Order of Registration. Without limiting the foregoing, the Board shall have the right, without notice, to draw upon the funds of said account for the payment of costs and expenses incurred by the Board and its staff in the surveillance, monitoring and investigative review of all activities of Station Casinos, Inc. and its subsidiaries, and their affiliated entities.

21. THAT pursuant to NRS 463.625, Station Casinos, Inc. is exempted from compliance with NRS 463.585 through NRS 463.615, inclusive, and shall instead comply with NRS 463.635 through NRS 463.645, inclusive.

22. THAT Station Casinos, Inc. is exempted from NGC Regulation 15 and shall instead comply with the provisions of NGC Regulation 16; provided, however, that, pursuant to NGC Regulation 16.450, Station Casinos, Inc. is exempted from the provisions of NGC Regulations 16.100(1) and (2) and the balance of NGC Regulation 16 shall be interpreted so as to apply to Station Casinos, Inc.

23. THAT the Commission hereby expressly finds that the exemptions hereinabove granted are consistent with the State policy set forth in NRS 463.0129 and NRS 463.489.
