AMENDED ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board at Carson City on August 18, 1976, and before the Nevada Gaming Commission at Carson City on August 26, 1976; and

THE APPLICANT having presented evidence and made arguments; and

THE COMMISSION having considered the reports of the Securities Division, the Nevada State Fire Marshall, the Nevada State Division of Health and the recommendation of the Board and other relevant and material evidence; and

NO PERSON having appeared in opposition to the granting of the application;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the following applications, as supplemented and amended be, and they hereby are, accepted as filed:

a. the application of SCOTT CORPORATION for an amended order of registration and to be found suitable to be the sole stockholder of SCOTT MIZPAH, INC.,

18 hereby is amended as follows:

20 istered as a publicly traded corporation and is
21 found suitable to be the sole stockholder of
22 SCOTT PLAZA, INC., AND SCOTT MIZPAH, INC.

23 3. THAT the application of SCOTT MIZPAH, INC., for a non-
24 restricted gaming license as the owner and operator of the MIZPAH
25 HOTEL, Tonopah, Nye County, Nevada be and the same is hereby
26 approved.

27 4. THAT the individuals listed in subparagraph 1(c) be,
28 and they hereby are, licensed in the positions indicated.

29 5. THAT all other terms and conditions of the Order of
