THIS MATTER came on regularly for hearing before the State Gaming Control Board on June 16, 1982, and before the Nevada Gaming Commission on June 24, 1982, at Las Vegas, Nevada, and

THE APPLICANTS having presented evidence in support of their applications, and

NO PERSON having appeared in opposition to the applications, and

THE BOARD AND COMMISSION having considered the report of the Investigative Division,

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

1. THAT the application of Nevada Electronic Wire Service, Inc., to be licensed to receive fifty percent (50%) of the profits of Nevada Automated Betting Systems,

Inc., is hereby accepted as filed.

2. THAT paragraph 5 of, Amendment No. 3 to Order of Registration of Scott Corporation, and paragraph 5, of Order of Registration of Union Pacific Corporation, are hereby rescinded and in lieu thereof the following is approved:

(a) THAT Scott Development Corporation is hereby registered as an intermediary holding company and found suitable to be the sole stockholder of: (i) Scott Plaza, Inc., dba Union Plaza Hotel & Casino, and Union Plaza Hotel & Casino, Race Book - Sports Pool, gaming licensees at One Main Street, Las Vegas, Nevada; (ii) Scott Mizpah, Inc., dba Mizpah Hotel, a gaming licensee in Tonopah, Nevada, (iii) Nevada Electronic Wire Service, Inc., and the following officers and directors of Scott Development Corporation are found suitable in the capacities indicated:

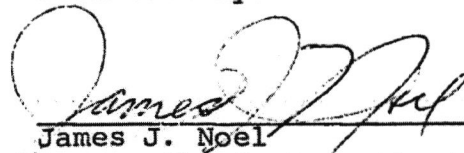
