At its meeting on February 26, 2026, the Nevada Gaming Commission (NGC) adopted amendments to certain provisions of the NGC Regulations, as identified below. Unless otherwise noted, the amendments became effective upon adoption on February 26, 2026. The adopted amendments have been codified into the pertinent chapters of the NGC Regulations.
