Nevada Gaming Revenues and Collections

Win Revenue Summary – August 2025

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,227,895,743 for the month of August 2025. This amounts to a 5.49% increase compared to August 2024, when licensees reported a gaming win of \$1,164,045,258.

Percentage Fee Collections for the Month of September 2025

The State collected \$77,126,326 in percentage fees during the month of September 2025*, based upon the taxable revenues generated in August 2025. This represents a 33.71% (or \$19,443,724) increase compared to the prior year's September, when percentage fee collections were \$57,682,602.
