Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,283,210,629 for the month of September 2025. This amounts to a 2.26% decrease compared to September 2024, when licensees reported a gaming win of \$1,312,905,548. For the fiscal year (July 1, 2025 through September 30, 2025), gaming win has increased 2.27%.

Percentage Fee Collections for the Month of October 2025

The State collected \$87,009,335 in percentage fees during the month of October 2025*, based upon the taxable revenues generated in September 2025. This represents a 12.35% (or \$12,257,749) decrease compared to the prior year's September, when percentage fee collections were \$99,267,084.
