PURPOSE: To amend NGC Regulation 5.300(1) to clarify the applicability of sections 5.300 to 5.380 based on NRS 463.0144; to amend NGC Regulations 5.300(2) and (3) to correct cross reference formats; to amend NGC Regulation 5.300(3) to contain the standard waiver or modification language and to add flush language thereto to state the Chair may condition, limit, and repeal any waiver or modification granted pursuant to the subsection; to amend NGC Regulation 5.300(4) to add a reporting requirement for events falling under the subsection; to amend NGC Regulation 5.035(2) to include access to pool cabanas and other venue seating under the types of waived or complimentary items listed in the definition of "consideration"; to amend NGC Regulation 5.320(1) to (5) to correct cross reference formats; to amend NGC Regulation 5.320(2) to include "cashiers" as club venue employees; to amend NGC Regulations 5.335(1) and 5.345(1) to correct cross reference formats; to add NGC Regulation 5.350, which would require licensees to notify the Nevada Gaming Control Board ("Board") of the opening of new club venues, changes in the ownership of club venues, and the closure of club venues, and to authorize the Board Chair, or the Chair's designee, to waive or modify a timeline provided in the section; to amend NGC Regulation 5.360(3) to reduce the time licensees have to submit changes to a club venue's annual policies and the time the Board Chair has to notify licensees of any disapproval thereof from 60 days to 30 days; to amend NGC Regulations 5.370(5) and (7) to correct cross reference formats; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

PURPOSE: In accordance with NRS 463.145 and 463.150, to amend subsection 1 of NGC Regulation 5.160 to revise the definition of “licensee” to include a restricted operation; to amend subsection 9 of NGC Regulation 5.160 to revise the required contents of written casino surveillance system plans and to require licensees to update and maintain those plans on the premises rather than submit annual updates to the Board; to repeal subsection 10 of NGC Regulation 5.160 regarding Chair review of surveillance system plans; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

PURPOSE: To amend NGC Regulation 12.020 to correct certain cross references and to delete an unnecessary subsection that states an effective date; to amend NGC Regulations 12.030 and 12.050 to make certain nonsubstantive, grammatical corrections; to amend NGC Regulation 12.060 to revise the requirements regarding the redemption of chips and tokens; to amend NGC Regulation 12.070 to revise the requirements relating to the redemption and disposal of discontinued chips and tokens; to amend NGC Regulation 12.090 to revise the requirements for the disposition of discontinued promotional and tournament chips and tokens; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

- 2) WILLIAM HILL NEVADA I MUST COMPLY WITH NEVADA GAMING COMMISSION REGULATION 6.090 AS IT RELATES TO THE SUBMISSION OF AN ADEQUATE INTERNAL CONTROL SYSTEM AND COMPLIANCE WITH THE MINIMUM INTERNAL CONTROL STANDARDS FOR A COMPUTERIZED RACE BOOK AND SPORTS POOL.
- 3) PRIOR TO THE COMMENCEMENT OF COMPUTERIZED RACE BOOK AND SPORTS POOL AND/OR PARI-MUTUEL WAGERING POOL OPERATIONS, AN EXECUTED RESERVE AGREEMENT MUST BE RECEIVED AND APPROVED BY THE NEVADA GAMING CONTROL BOARD (AUDIT DIVISION), PURSUANT TO NEVADA GAMING COMMISSION REGULATIONS 5.225 AND 22.040.
- 4) THE SURVEILLANCE SYSTEM MUST BE INSPECTED AND APPROVED BY THE NEVADA GAMING CONTROL BOARD ENFORCEMENT DIVISION WITHIN 60 DAYS OF ISSUANCE OF THE STATE GAMING LICENSE AND THEREAFTER BE MAINTAINED AT OR ABOVE THE STANDARD THAT IS APPROVED.
- 5) PRIOR ADMINISTRATIVE APPROVAL BY THE NEVADA GAMING CONTROL BOARD CHAIR OR THE CHAIR'S DESIGNEE IS REQUIRED FOR WILLIAM HILL NEVADA I TO CONVERT A LOCATION FROM A KIOSK OPERATION TO A MANNED SATELLITE OPERATION, OR FROM A MANNED SATELLITE OPERATION TO A KIOSK OPERATION. IF ANY LICENSED LOCATION UTILIZES BOTH A MANNED SATELLITE OPERATION AND A KIOSK OPERATION, PRIOR ADMINISTRATIVE APPROVAL OF THE NEVADA GAMING CONTROL BOARD CHAIR OR CHAIR'S DESIGNEE IS REQUIRED PRIOR TO CLOSING OR REOPENING A MANNED SATELLITE OPERATION.

Hello good Morning. My name is Gustavo E Perez.

Being born and raised here in Vegas going 37 years this September. I've seen a lot of growth and expansion in my beautiful city of Las Vegas, NV. Having both my parents worked Union jobs and are now retired. I would like to have that same job security, same outcome not only for me but for my family. I've been working at Green Valley Resort Spa and Casino as a bartender for almost 10years. I love serving our locals, getting to know our locals making memories giving them the same experience they would get on the strip but better at Stations Casinos properties. But I feel all of Las Vegas Strip is union why not the 4th largest gaming company in Las Vegas?

Good morning. Aira Duyanen for the Culinary Union. My comments this morning are about the loss of housing, loss of security, and loss of health of Station Casinos employees.

Station Casinos faces one of the largest labor law enforcement actions in U.S. history. This law enforcement case involves thousands of employees across 10 casinos.

Here are some examples from public comments this body has heard before about the perils faced by Station employees, many of whom spent years working their way up to a secure rank only to have it taken away and all who suffered violations of their rights as provided by U.S. labor law.

1. An A-List banquet server's family lost their house after 14 years of dedicated service.
2. A dedicated A-Lister lost the mortgage for a new home build after 14 years of dedicated service.
3. Another lost a retirement plan when their layoff forced them to cash it out after 14 years of dedicated service.
4. A full-time server lost the financial security that allowed her to care for her disabled mother after 14 years of dedicated service.
5. A full-time cook's helper lost their higher wage and was demoted to a lower wage after 6 years of dedicated service.
6. A full-time server lost their health and suffers from depression after 14 years of dedicated service.
7. A dedicated server lost their job, was denied rehire and was temporarily homeless after 20 years of dedicated service.

These are the people that power the industry you regulate. The Culinary Union will never let Station Casinos get away with what it did to gaming industry workers during a national crisis. A Nevada gaming

license holder, like Station Casinos, is not above the state or federal law and we believe Stations will face the consequences of its actions.
