This public comment agenda item is provided in accordance with NRS 241.020(3)(d)(3) which requires an agenda provide for a period devoted to comments by the general public, if any, and discussion of those comments. **PUBLIC COMMENTS AND DISCUSSION: No comments.**

Good morning. Aira Duyanen for the Culinary Union. My comment this morning is about an internal Station Casinos document entered into evidence in a National Labor Relations Board proceeding. We believe this document contains an admission of unlawful activity that fits a pattern of habitual disregard of federal law by a license holder.

In 2021, the NLRB's general counsel issued an unfair labor practice complaint alleging that Station Casinos "engaged in a scheme to use employee layoffs during the COVID-19 pandemic to undermine unions representing or seeking to represent their employees."

As part of its ongoing prosecution of that complaint, government lawyers entered into evidence a document that supports our belief that Station Casinos eliminated jobs that it considered might be occupied by union supporters in order to undermine the union.

The document is titled "Corporate Human Resources Project List" and is dated February 25, 2020. It describes the status of ongoing corporate HR projects. Among them is an "On-Call Reduction" project, whose purpose was to "Reduce On-Call from 21% to less than 3%." The project priority is marked "High." It states in a comment box the reduction of on-call employees "Will result in eliminating approximately 1700 'union' votes for new elections / re-elections / Decerts." The term "decerts" refers to a process of a union's status as bargaining representative is eliminated.

The Project List likewise references a "Recognition Program Roll-out" project marked as High priority. The document states the purpose of this project is "to aggressively pursue non-union strategy. Will hire 'Supervisory Communications Consultant' for Spanish speaking leaders in BOH. Continue to train supervisors and above on overall non-union strategy." A comment states: "Underground decertification strategy on-going. Upon completion of reduction in On-Call staff we will aggressively pursue this BOH issue."

In sum, the Corporate HR document indicates in late February 2020, as Vegas and the gaming industry were heading into the pandemic and the shutdown, someone within Corporate HR at Station Casinos had a project in motion to undermine the union by eliminating on-call jobs. And while it is unlawful for management to orchestrate a decertification, the document indicates that there was an "Underground decertification strategy" ongoing as of February 2020. Station Casinos later withdrew recognition from the union at Boulder and Palace Station based upon employee signatures on a petition that the government alleges the company unlawfully assisted in gathering.

Today, please ask Mr. Welch, Mr. Cootey and Mr Nichols if their employer has a habit of disregarding federal labor law. Thank you.

My name is Thomas Principe. I am 24 years old. I have been a part time Bellman at Green Valley Ranch for 8 months.

Before my job with Station Casinos, I was working as a part time bellman at The Mirage where I had a Culinary Union contract. At the Mirage, I was getting 30 hours a week, 8 hours guaranteed a day, and \$17 starting hourly pay with guaranteed raises. I was living by myself and was comfortable financially.

Now, working at Green Valley Ranch, I am making only \$12 an hour. Oftentimes I check our weekly schedule, and am disappointed by seeing only 8 hours posted for me the entire week. I am rarely given a full 8 hour shift. I usually work odd hours such as 5 or 7 hours for the day. I feel as though I am not truly a part timer, but a glorified on-call worker, and that's hoping that I do get called in. I am currently living back home with my parents. With the rising price of living today, I don't

know how I could even be able to live on my own with my Green Valley Ranch current wages and hours.

When I was covered by a contract with the Culinary Union, I felt safe knowing that I had protection for work hours and livable wages.

9 years ago, GVR workers voted to go union with a 78% vote. A union contract gives transparency and most importantly respect to someone, like me, who is just trying to survive.

Workers at Station Casinos deserve these things.

I ask you, the Nevada gaming regulators, to take what younger people like me say very seriously, because if younger people don't see that they have an opportunity for a career in this industry, then the industry's future may be in trouble.
