PUBLIC COMMENTS AND DISCUSSION: No comments.

Good morning. My name is Adam Christian. I work at Red Rock Casino, as a food server at T-Bones. I've worked there for 18 years. I'm a Union leader and I wear my Union button and organize everyday.

My employer put me on their MUD List as pro-Union.

What I and my coworkers want is simple and not complicated.

We want respect. We want the discrimination to stop. And we want a contract now.

Good morning. Rory Kuykendall for the Culinary Union. Oral arguments are set to begin next month at the D.C. Circuit Court of Appeals in an appeal involving Red Rock Casino Resort & Spa. We have a copy of the D.C. Circuit's order on oral arguments to submit today along with our comments.

At stake in the appeal is whether a June 2024 decision and order by the National Labor Relations Board was correctly decided. Among other things, the NLRB found that Red Rock Casino Resort & Spa's "extensive coercive and unlawful misconduct stemmed from a carefully crafted corporate strategy intentionally designed at every step to interfere with employees' free choice whether or not to select the Union as their collective-bargaining representative." The NLRB also found that "the most important unfair labor practices here were planned and executed by the Respondent's and Station Casinos' top management and owners, for the express purpose of interfering with employees' Section 7 rights."

In reaching its decision, the NLRB questioned the credibility of testimony provided by Red Rock Casino Resort's Chief Financial Officer and Chief Legal Officer, finding they "testified with such an unusual degree of evasiveness and wholly implausible forgetfulness that the judge was fully warranted in discounting their testimony as generally unreliable."

If the D.C. Circuit sides with the NLRB, then its finding will stand that Red Rock Resorts Inc.' CFO or CLO were not credible witnesses on the subjects they testified about.

As we have urged you before, you should ask yourselves: why there should be even a doubt about a Nevada gaming company CFO's and CLO's ability to provide transparent testimony in a

government proceeding? We hope you will follow the Red Rock Casino appeal before the D.C.

Circuit.
