### **Nevada Gaming Revenues and Collections**

### Win Revenue Summary – July 2025

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$1,359,029,244 for the month of July 2025. This amounts to a 3.99% increase compared to July 2024, when licensees reported a gaming win of \$1,306,841,233.

### Percentage Fee Collections for the Month of August 2025

The State collected \$95,533,943 in percentage fees during the month of August 2025\*, based upon the taxable revenues generated in July 2025. This represents a 0.38% (or \$364,885) decrease compared to the prior year's August, when percentage fee collections were \$95,898,828.
