Nevada Gaming Revenues and Collections

Win Revenue Summary – November 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,347,961,090 for the month of November 2025. This amounts to a 2.39% increase compared to November 2024, when licensees reported a gaming win of \$1,316,558,624. For the fiscal year (July 1, 2025 through November 30, 2025), gaming win has increased 2.83%.

Percentage Fee Collections for the Month of December 2025

The State collected \$82,486,522 in percentage fees during the month of December 2025*, based upon the taxable revenues generated in November 2025. This represents a 5.37% (or \$4,685,422) decrease compared to the prior year's November, when percentage fee collections were \$87,171,944.
