Nevada Gaming Revenues and Collections

Win Revenue Summary – October 2025

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$1,350,043,348 for the month of October 2025. This amounts to a 4.95% increase compared to October 2024, when licensees reported a gaming win of \$1,286,404,175. For the fiscal year (July 1, 2025 through October 31, 2025), gaming win has increased 2.95%.

Percentage Fee Collections for the Month of November 2025

The State collected \$83,674,693 in percentage fees during the month of November 2025*, based upon the taxable revenues generated in October 2025. This represents a 5.00% (or \$3,984,300) increase compared to the prior year's October, when percentage fee collections were \$79,690,393.
