
Good morning. Aira Duyanen for the Culinary Union. My comments are about Durango Casino and Resort's Vice President and General Manager David Horn. Last month, we contacted the Nevada Gaming Control Board about Mr. Horn's gaming license history and was informed he was first registered in June 2006. On February 22, 2024, the Nevada Gaming Commission approved his application for licensure as a key employee at Durango.

An employer and a GM like David Horn violates federal labor law by encouraging, promoting, or providing assistance to employees seeking to decertify their union. On January 11, 2020, Horn, who at the time was Palace Station's VP and GM, texted a colleague and referred to the Station Casinos Senior Vice President of Labor Relations and Strategy. "[He] says to get me the names of the people who can help with decertification but don't get directly involved." The term decertification refers to a process of a union's status as bargaining representative is eliminated. By February 25, 2020—a little over a month after the Horn text—Station Casinos' Corporate HR department was in possession of a document entitled "Corporate Human Resources Project List." One line on that document reads "Underground decertification strategy on-going."

Station Casinos withdrew recognition from the Union at Palace Station on September 21. The next day, GM Horn texted Terry D. "I got the decertification of the Union completed. We submitted to them yesterday. Fucking lost part of my life in taht process. Craziest deal ever."

In a span of nine months, GM Horn's statements went from "don't get directly involved" to "I got the decertification of the Union completed." By way of analogy: If GM Horn were ever directed to assist Station Casinos in violating federal tax law, we assume you would have a serious problem with that. We also assume that if the National Labor Relation Board finds that GM Horn was directed to assist Station Casinos in violating federal labor law by supporting a decertification effort, you would have a serious problem with that too.

We believe a Nevada gaming license holder who is a Vice President and General Manager of a casino resort should be held accountable for any role he may be found to have played in unlawful activity. And at the very least, the Board should have zero tolerance for “underground strategies” that undermine the stability of the industry. Thank you.


