2025-13R: PROPOSED AMENDMENTS TO NGC REGULATION 5A.060 CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 5A.060 REGARDING, WITHOUT LIMITATION, TO CLARIFY DEFINITIONS/TERMINOLOGY (INCLUDING REMOVAL OF “NEW”) AND REPEAL THE REQUIREMENT TO SUBMIT A LIST OF PERSONS WITH ACCESS TO THE SYSTEM’S MAIN COMPUTER OR DATA COMMUNICATIONS COMPONENTS; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To amend NGC Regulation 5A.060(1) to replace the term “operator” with “operator of an interactive gaming system” for clarity purposes and to remove the word “new” from the subsection; to repeal NGC Regulation 5A.060(2) removing the requirement for an operator of an interactive gaming system to provide a list of persons who may access the main computer or data communication components of an approved interactive gaming system; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

Regulation adopted, draft dated December 16, 2025, effective upon adoption.

2. FOR POSSIBLE ADOPTION, AMENDMENT, OR REPEAL

2025-14R: PROPOSED AMENDMENTS TO NGC REGULATION 6.110 CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 6.110 REGARDING, WITHOUT LIMITATION, TO AUTHORIZE THE CHAIR, FOR GOOD CAUSE SHOWN, TO APPROVE AN ALTERNATE BUT SUBSTANTIVELY COMPARABLE METHOD OF GROSS REVENUE COMPUTATION; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: In accordance with NRS 463.145, NRS 463.150, to amend NGC Regulation 6.110 to allow the Chair, for good cause shown by the licensee, to approve an alternate but substantively comparable method of gross revenue computation; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

Regulation adopted, draft dated October 17, 2025, effective upon adoption.

2025-15R: PROPOSED AMENDMENTS TO VARIOUS SECTIONS OF NGC REGULATION 14 CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 14 REGARDING, WITHOUT LIMITATION, TO UPDATE GAME AND GAMING DEVICE APPROVALS (INCLUDING AB 58 ADMINISTRATIVE APPROVALS), DEFINITIONS, DISTRIBUTION REQUIREMENTS, INDEPENDENT TESTING LAB SUBMISSIONS, AND RELATED TECHNICAL TERMINOLOGY AND CROSS-REFERENCES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To amend NGC Regulation 14 to revise, remove, or add various requirements and standards relating to the approval and modification of games, gaming devices, and associated equipment, and to the revocation of such approvals; to amend NGC Regulation 14.010 to add new definitions or to modify existing definitions relevant to the amendments set forth herein; to amend NGC Regulations 14.100 and 14.250 to allow for administrative approval of new gaming devices and new games as provided in section 6 of Assembly Bill 58 adopted during the 2025 session of the Nevada Legislature; to amend NGC Regulations 14.180 and 14.190 to revise the requirements relating to the distribution of gaming devices; to amend NGC Regulation 14.400 to modify what information and items must be provided by an independent testing lab in association with the licensed manufacturer of a gaming device; to amend NGC Regulation 14 to make non-substantive changes to standardize terminology and cross references; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

And in our estimation, winning in this case could result in a sizable financial liability owed by Red Rock to the workers whose rights it is found to have violated.
