This public comments agenda item is provided in accordance with NRS 241.020(3)(d)(3) which requires an agenda provide for a period devoted to comments by the general public, if any, and discussion of those comments. No action may be taken upon a matter raised under this item of the agenda until the matter itself has been specifically included on an agenda as an item upon which action will be taken. PUBLIC COMMENTS AND DISCUSSION: No comments.

Good morning. Aira Duyanen for the Culinary Union. A US Court of Appeals this June upheld an NLRB finding that the Chief Financial Officer of Red Rock Resorts Inc. was not a credible witness based on testimony under oath before an NLRB Administrative Law Judge in 2021.

I would like to take a moment to walk you through this matter chronologically.

In November 2019, the CFO participated in an executive leadership meeting at which a “strategic plan” for undermining the union through improved healthcare and retirement benefits was presented for approval to the controlling owners of Red Rock Resorts.

In April 2021, that CFO was asked about the strategic plan during testimony under oath before the Administrative Law Judge.

One year later, the ALJ found that the CFO’s testimony about the strategic plan was not credible, that certain reports introduced by Red Rock Casino “do not corroborate [the CFO’s] testimony,” and that the CFO “exaggerated” parts of his testimony.

In June 2024, the NLRB upheld the ALJ’s finding that the CFO’s testimony lacked credibility.

And as I said in the beginning, this June a US Court of Appeals further upheld the government’s credibility determination.

NRS 463.170(2a) requires a gaming license holder be a “person of good character, honesty and integrity.”

Because a federal court has upheld the decision of a federal agency in the matter of CFO’s lack of credibility under oath, we believe that an investigation into the CFO’s honesty in legal proceedings is warranted.

In September 2022, this Commission received testimony from this same CFO about the fact that he had been arrested in 2020 and that his blood alcohol content four hours after he had been picked up was, in the words of one Commissioner, “significant.” The Commissioner observed

that there appeared to be a discrepancy between what the blood alcohol analysis showed and what the CFO had told law enforcement he had been doing prior to being arrested—coming home from work. The CFO responded that he did not recall his conversation with the law enforcement officer.

Examining the CFO's testimony from the 2021 NLRB proceeding would therefore not be the first time the Commission has had statements by Red Rock Resort CFO to law enforcements put before it. And we urge you to enforce NRS 463.170(2a) in regards to Red Rock Resort's CFO.
