PURPOSE: In accordance with NRS 463.145, NRS 463.150, to amend NGC Regulation 5.225 to provide additional permissible methods to deposit and withdraw funds from wagering accounts; to amend NGC Regulations 5.240 and 5.242 to repeal cloud computing service provider as a type of service provider that must be registered with the Board and repeal associated regulatory provisions, and to amend provisions related to who may act as a service provider without registering with the Board as a service provider, and to provide under what circumstances a licensee may utilize cloud computing services; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

PURPOSE: In accordance with NRS 463.145, NRS 463.150, to amend NGC Regulation 6.110 to allow the Chair, for good cause shown by the licensee, to approve an alternate but substantively comparable method of gross revenue computation; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

4. 2025-15R—NGC REGULATION 14 - MANUFACTURERS, DISTRIBUTORS, OPERATORS OF INTER-CASINO LINKED SYSTEMS, GAMING DEVICES, NEW GAMES, INTER-CASINO LINKED SYSTEMS, ON-LINE SLOT METERING SYSTEMS, CASHLESS WAGERING SYSTEMS, MOBILE GAMING SYSTEMS, INTERACTIVE GAMING SYSTEMS AND ASSOCIATED EQUIPMENT; INDEPENDENT TESTING LABORATORIES AND THE TECHNICAL STANDARDS FOR GAMING DEVICES AND ASSOCIATED EQUIPMENT: VARIOUS SECTIONS

PURPOSE: In accordance with NRS 463.145, NRS 463.150, to amend NGC Regulation 14 to revise, remove, or add various requirements and standards relating to the approval and modification of games, gaming devices, and associated equipment, and to the revocation of such approvals; to amend NGC Regulation 14.010 to add new definitions or to modify existing definitions relevant to the amendments set forth herein; to amend NGC Regulations 14.100 and 14.250 to allow for administrative approval of new gaming devices and new games as provided in section 6 of Assembly Bill 58 adopted during the 2025 Session of the Nevada Legislature; to amend NGC Regulations 14.180 and 14.190 to revise the requirements relating to the distribution of gaming devices; to amend NGC Regulation 14.400 to modify what information and items must be provided by an independent testing lab in association with the licensed manufacturer of a gaming device; to amend NGC Regulation 14 to make non-substantive changes to standardize terminology and cross references; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

DISCUSSION OF PROPOSED REVISIONS TO STANDARDS 1, 2, AND 4 REGARDING, WITHOUT LIMITATION, WHOLESALE REVISION, CONSOLIDATION, AND MODERNIZATION OF REQUIREMENTS INTO A SINGLE UPDATED STANDARD; MODERNIZATION OF TERMINOLOGY AND REQUIREMENTS THROUGHOUT THE TECHNICAL STANDARDS; ALIGNMENT WITH OTHER NATIONALLY RECOGNIZED TECHNICAL STANDARDS; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: Pursuant to NGC Regulation 14.050, to amend NGCB technical standards 1, 2, and 4 to make wholesale revisions to the requirements contained therein and to consolidate those requirements into technical standard 1; to amend the technical standards to modernize terminology and the requirements set forth currently in technical standards 1, 2, and 4; to amend the requirements set forth currently in technical standards 1, 2, and 4 to bring those standards in-line with other nationally recognized standards; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.
