DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATION 3.010 REGARDING, WITHOUT LIMITATION, EVIDENTIARY CRITERIA FOR DETERMINING LOCATION SUITABILITY NEAR CHURCHES, SCHOOLS, OR PLAYGROUNDS; DEFINITIONS; APPLICANT STATEMENTS OF SUITABILITY; PRESUMPTIONS OF SUFFICIENT SHOWING; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To add specific additional items of evidence which may be considered by the Board and Commission when determining the suitability of a location near a church, school, or playground; to define terms used in Regulation 3.010; to require an applicant to provide a statement or determination concerning the suitability of a location; to create a presumption of sufficient showing of suitability; and to take such additional action as may be necessary and proper to effectuate this stated purpose.

2. 2025-06R—NGC REGULATION 5 – OPERATION OF GAMING ESTABLISHMENTS: CLUB VENUES

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATION 5 REGARDING, WITHOUT LIMITATION, CLARIFICATION OF THE APPLICABILITY OF REGULATIONS 5.300–5.380 CONSISTENT WITH NRS 463.0144; CORRECTIONS TO CROSS-REFERENCE FORMATS IN REGULATIONS 5.300(2)–(3), 5.320(1)–(5), 5.335(1), 5.345(1), AND 5.370(5) & (7); REPEAL OF REGULATION 5.300(4) (EXCEPTION FOR LIMITED-FREQUENCY VENUES); AMENDMENT TO REGULATION 5.035(2) TO INCLUDE ACCESS TO POOL CABANAS AND OTHER VENUE SEATING WITHIN “CONSIDERATION”; AMENDMENT TO REGULATION 5.320(2) TO INCLUDE “CASHIERS” AS CLUB VENUE EMPLOYEES; ADOPTION OF NEW REGULATION 5.350 REQUIRING NOTICE TO THE BOARD OF CLUB VENUE OPENINGS, OWNERSHIP CHANGES, AND CLOSURES AND AUTHORIZING THE CHAIR TO WAIVE OR MODIFY TIMELINES; AMENDMENT TO REGULATION 5.360(3) TO REDUCE FROM 60 TO 30 DAYS THE DEADLINES FOR SUBMISSION AND CHAIR REVIEW OF CLUB VENUE ANNUAL POLICIES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To amend NGC Regulation 5.300(1) to clarify the applicability of sections 5.300 to 5.380 based on *Nevada Revised Statutes* (NRS) 463.0144; to amend NGC Regulations 5.300(2) and (3) to correct cross reference formats; To repeal NGC Regulation 5.300(4), which provides an exception for venues that only hold certain types of events at a certain frequency; to amend NGC Regulation 5.035(2) to include access to pool cabanas and other venue seating under the types of waived or complimentary items listed in the definition of “consideration”; to amend NGC Regulation 5.320(1) to (5) to correct cross reference formats; To amend NGC Regulation 5.320(2) to include “cashiers” as club venue employees; to amend NGC Regulations 5.335(1) and 5.345(1) to correct cross reference formats; to add NGC Regulation 5.350, which would require licensees to notify the Board of the opening of new club venues, changes in the ownership of club venues, and the closure of club venues, and to authorize the Board Chair, or the Chair’s designee, to waive or modify a timeline provided in the section; to amend NGC Regulation 5.360(3) to reduce the time licensees have to submit changes to a club venue’s annual policies and the time the Board Chair has to notify licensees of any disapproval thereof from 60 days to 30 days; to amend NGC Regulations 5.370(5) and (7) to correct cross reference formats; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

3. 2025-07R—NGC REGULATION 5.160 – OPERATION OF GAMING ESTABLISHMENTS AND THE SURVEILLANCE STANDARDS FOR NONRESTRICTED LICENSEES

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATION 5.160 AND THE SURVEILLANCE STANDARDS REGARDING, WITHOUT LIMITATION, UPDATES TO LICENSEE SUBMISSION REQUIREMENTS IN SECTIONS 9 AND 10; REVISIONS TO SURVEILLANCE STANDARDS §1.010; UPDATE OF LICENSE CATEGORIES IN §1.020 FROM REVENUE-BASED TO ACTIVITY-BASED; AMENDMENTS TO §2.010 ON SURVEILLANCE EQUIPMENT, STAFFING CLASSIFICATIONS, TRAINING, AND MALFUNCTION NOTIFICATIONS; MODERNIZATION OF MINIMUM REQUIREMENTS IN STANDARDS 1–8 (SLOTS, TABLES, CARD GAMES, KENO, BINGO, RACE/SPORTS/PARI-MUTUEL, CAGE/VAULT, COUNT ROOMS, SECURITY OFFICES); UPDATES TO STANDARD 9 (RECORDKEEPING), UPDATES TO STANDARD 10 (GAMING SALONS); UPDATES TO STANDARD 11 (CLUB VENUES); STANDARD 12 (RECORDING TECHNOLOGY), AND STANDARD 13 (SYSTEM REQUIREMENTS); ADOPTION OF NEW STANDARD 14 FOR RESTRICTED LICENSEES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To amend NGC Regulation 5.160 to amend sections 9 and 10 to update submission requirements by licensees; to amend Surveillance Standards section 1.010 to revise, remove, or add various requirements and standards relating to the surveillance of various portions of licensee properties; to amend section 1.020 to update license categories from revenue-based to activity-based; to amend section 2.010 related to surveillance equipment to reflect the current employee classifications and occupational training and abilities and to include required notifications related to surveillance malfunctions; to amend Surveillance Standards 1-8 to update the minimum requirements for surveillance of slot machines, table games, card games, keno, bingo, race books, sports pools, pari-mutuel books, casino cage and vault, count rooms and security offices; to amend Surveillance Standard 9 to update the minimum requirements for surveillance record keeping; to amend Surveillance Standard 10 and 11 to update payout standards and surveillance locations in gaming salons and club venues; to amend Surveillance Standard 12 to align recording standards with technological advancements; to amend Surveillance Standard 13 to update requirements of the overall system; to add Standard 14 to include Restricted licensees; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATION 12 REGARDING, WITHOUT LIMITATION, CORRECTION OF CROSS-REFERENCES AND REMOVAL OF AN OBSOLETE EFFECTIVE-DATE SUBSECTION IN REGULATION 12.020; NON-SUBSTANTIVE GRAMMATICAL REVISIONS TO REGULATIONS 12.030 AND 12.050; REVISIONS TO REQUIREMENTS FOR REDEMPTION OF CHIPS AND TOKENS IN REGULATION 12.060; REVISIONS TO REQUIREMENTS FOR REDEMPTION AND DISPOSAL OF DISCONTINUED CHIPS AND TOKENS IN REGULATION 12.070; REVISIONS TO REQUIREMENTS FOR DISPOSITION OF DISCONTINUED PROMOTIONAL AND TOURNAMENT CHIPS AND TOKENS IN REGULATION 12.090; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To amend NGC Regulation 12.020 to correct certain cross references and to delete an unnecessary subsection that states an effective date; to amend NGC Regulations 12.030 and 12.050 to make certain non-substantive, grammatical corrections; to amend NGC Regulation 12.060 to revise the requirements regarding the redemption of chips and tokens; to amend NGC Regulation 12.070 to revise the requirements relating to the redemption and disposal of discontinued chips and tokens; to amend NGC Regulation 12.090 to revise the requirements for the disposition of discontinued promotional and tournament chips and tokens; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

5. 2025-09R—NGC REGULATION 22 – RACE BOOKS AND SPORTS POOLS

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATIONS 22.060, 22.090, AND 22.150 REGARDING, WITHOUT LIMITATION, REQUIRED SPECIFIC LANGUAGE IN BOOK HOUSE RULES; REMOVAL OF THE CHAIR-APPROVAL REQUIREMENT FOR HOUSE RULES AND PARLAY CARD RULES; MAINTENANCE OF PRIOR VERSIONS OF HOUSE AND PARLAY CARD RULES; AUTHORIZATION FOR THE CHAIR TO DIRECT AMENDMENTS TO SUCH RULES; UPDATES TO ACCEPTABLE SOURCES OF OUTCOME REPORTING; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: To require specific language be incorporated at the front of book house rules; to remove the requirement that the Board Chair approve house rules and parlay card rules or amendments thereto; to require maintenance of prior versions of house rules and parlay card rules; to authorize the Board Chair to direct a book to amend its house rules or parlay card rules; to update the acceptable sources of outcome reporting; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

6. 2025-10R—NGC REGULATION 28 – LIST OF EXCLUDED PERSONS

DISCUSSION, AND POSSIBLE RECOMMENDATION TO THE NEVADA GAMING COMMISSION, OF AMENDMENTS TO NGC REGULATIONS 28.040 AND 28.090—IN ACCORDANCE WITH NRS 463.145, 463.150, AND 463.151, REGARDING, WITHOUT LIMITATION, PUBLICATION OF THE EXCLUDED PERSONS LIST ON THE BOARD'S WEBSITE IN LIEU OF DISTRIBUTION; REPEAL OF REQUIREMENTS FOR LICENSEES TO DIRECT EXCLUDED PERSONS TO LEAVE AND TO NOTIFY LAW ENFORCEMENT AND THE BOARD UPON NONCOMPLIANCE; RELATED CONFORMING AMENDMENTS; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: In accordance with NRS 463.145, 463.150, and 463.151, to amend Regulation 28.040 to repeal requirements to distribute the list and instead require publication of the list to the Board's website; to amend Regulation 28.090 to repeal that a licensee, its agents, or employees are required to request an excluded person to not enter or if on the premises to immediately leave and to notify the appropriate local law enforcement agency and the Board if the excluded person fails to comply with the request and to amend related provisions; and to take such additional action as may be necessary and proper to effectuate these stated purposes.
